## Honking Is Not Enough

STOPPING at a traffic light in Goshen, Indiana, I noticed the bumper sticker on the car ahead of me: "If You Love Jesus Honk."

"Why not?" I asked myself. It was a Sunday evening, and I surmised that the driver probably on his way to church. He and his wife and small daughter were obviously dressed better than they would have been for buzzing over to a McDonald's. After all, a response to the bumper sticker might give him a touch of prechurch service inspiration to know that others in the world loved Jesus also

I touched the horn button ever so lightly and gave two polite little beeps. Just as I gave the first one, the light changed from red to green.

The response from the driver was immediate and unexpected. He turned his head and glared at me; if looks could kill, I certainly would not be around to tell this story! Then, with a squeal of protesting rubber on pavement, the car lunged forward.

"Well!" I thought to myself. "Something seems to have gone wrong somewhere. Perhaps he thought I was impatiently honking for him to start. Maybe he's forgotten the message on the bumper sticker. Or perchance his wife has burned the evening meal."

I planned to catch up with him at the next traffic light, pull up beside his car, and flash a friendly grin just to let him know that everything was all right. But the chance did not come. He zoomed through the next light just as it was changing. As I obediently stopped I saw his car careen around a corner one block ahead, and it disappeared.

Long after I had left Goshen behind me, I pondered over his reaction; I found myself hoping that the sermon he heard cooled him down

Since then I've often wondered: What in the world does the honking of an auto horn have to do with loving someone?

My son Mike used to work in the custodial department of a small university in southwestern Michigan. Between our house and his place of work lived Sandy, a girl he knew. Each time he passed her house he would slap his hand down heavily on the horn, causing it to emit an ear-splitting screech.

Once when riding with him I

asked him why he did this.

"I dunno," he answered. "I suppose it's to let her know that I like her."

"But what about the neighbors," I asked him, "and the fact that you honk even when you pass her house at eleven-thirty at night?"

"Oh, I don't think they mind much," he answered in a tone that indicated he himself was not convinced of the truth of what he was saving.

I continued quizzing him. "If you like her so much, why don't you think about asking her to marry vou?"

"It isn't anything serious, Popsy. I just think that she's a lot of fun. and-"

By that time we were home, and I never did hear the rest.

I love Darlene, my wife. In fact—despite statements from the authorities that there is no such thing as love at first sight—I have loved her since the time, over thirty years ago, I first looked in the seat behind me at church and saw her there. But I wonder what she would think if, on our wedding anniversary or her birthday, I limited my expression of love to a honk of the horn as I drove up the driveway after a day's work.

As I came in the house she would probably ask me (trying to be subtle), "Honey, do you know what day this is?"

And I would answer, "Sure. That's why I honked as I drove in."

She would probably wait a few moments, then ask with a tone of disappointment evident in her voice, "Is that all?"

"Yep," I'd reply in this purely hypothetical case. "Isn't that enough for you?"

Assuredly, that would not be the secret of promoting a happy marriage!

Honking is just not enough to show love, it seems. It takes more than that—much more. In the case of Darlene and me, it takes an occasional "surprise" present, a little love pat, or helping her do the dishes when she is tired at the end of a long day. And many other things also.

And what does the Lord expect of those who claim to love Him? A honk of their auto horn? A tiny golden cross worn on the dress or lapel? A bumper sticker proclaiming that "I Love Jesus"?

He answered this question long ago when He told His disciples just before He was crucified, "If a man loves me, he will keep my word" (John 14:23). Just a few moments before this He had told them, "He who has my commandments and keeps them, he it is who loves me; and he who loves me will be loved by

my Father, and I will love him and manifest myself to him" (verse 21).

That rule applies in secular as well as spiritual things. If we love others, we try to please them; we try to do what they want us to do. So we please the Lord by keeping His commandments. We do not keep them to earn our way to salvation, for this we can never do if we were to "be good" all our lives (see Ephesians 2:8,9).

Predicting conditions in the troubled times just before Jesus' second coming, the apostle Paul described most of humanity as "lovers of self, lovers of money, and lovers of pleasure rather than lovers of God" (2 Timothy 3:1-4). And he counseled youth Timothy that, as a Christian, he should "avoid such people" (verse 5).

We find much that is called "love" in the world today, but the greater portion of it is as fake as a three-dollar bill. Henry Drummond calls it "the greatest thing in the world." He says further that love is "Christ's one secret of the Christian life."

If, as Christ said, love involves obedience to Him, then only a casual glance at most of Christendom shows its lack. In the present-day world the Ten Commandments are considered of little importance to the Christian. "Only honk your spiritual horn of faith," we are told by some theologians, "and you can forget about the law of God, for you do not need to keep it now."

But the apostle James had another point of view in this matter. After discussing the law of God and its relationship to a practical demonstration of one's love to God and other people, he said unequivocally, "Faith by itself, if it has no works, is dead" (James 2:17).

So horn-honking is not enough for the Lord. He wants our obedience to His laws as evidence of our faith in and love for Him.

## Are We to Have a National "Common Rest Day" Law?

It seems that there is a thinly veiled threat that this will occur. I only suggest that those thinking otherwise read on microfilm at their public libraries these issues of the *New York Times*: June 18, page 1, section 2, pages 4, 5, and 7; June 21, page 33: 1, August 28, front page. Possibly many others have similar items.

On June 17, the State of New York's highest court declared that the "Sabbath" selling law was unconstitutional! All members agreed on this decision. They did not rule on other parts of the law, forbidding "common labor."

Since then an increasing number of stores have started opening on Sunday. On August 29, (Sunday) the giant Macy and Gimbel department

stores were open for the first time ever on a Sunday.

High officials of the Catholic Church are urging that the New York legislature enact a strong "Common Rest Day" Law. They are asking their members (millions) not to shop Sundays. Protestant clergymen for the most part agree with them. Most letters to editors and articles in papers and magazines also agree. All mention the "sabbath." Not one that I have read mentions anything about the seventh-day observers. They all decry "that the 30 states having Sunday Laws are failing to obey them."

Isn't it time that all Sabbath keepers write the New York news media and the three major radio/television networks, giving the seventh day side of the Sabbath? # WHY GIVE BEFORE 1977 ?

As the old year takes its bows the stage must be cleared for new ideas, experiences, and goals. It is a time for catching up and starting over, for undoing and redoing, for tying up the loose ends. Last year's resolutions are inventoried, sorted, and reclassified under "ACCOMPLISHED" or "CARRIED OVER FOR NEXT YEAR."

From a practical standpoint it is a good time to review financial factors as well. For most people January begins a new tax season and after December 31 it will be too late to have deductions apply on this year's income tax return. It is also the one time of the year when we are most aware of our overall financial picture, earnings, expenses, etc. In other words, we are in a better position to judge what we can afford to give after our own needs are met.

Whether you are balancing the family checkbook or directing a multimillion dollar corporation, now is a good time to decide what you want to give, to whom, and how you want to give it.

## What Should I Give?

#### I. Cash

Back when our country was young and bartering was a common system of exchange, money may have been the least likely thing one would have considered giving. If someone were in need, a neighbor would give food from his garden, timber from his land, or maybe even flour from his mill. In today's economy, however, though we may still take food to a sick neighbor, cash is the most convenient charitable gift. Cash can be exchanged for whatever is needed most, whether it be medicine, food, books, or workers.

When making a cash gift, you can give up to 50 percent of your adjusted gross income and deduct it on your federal income tax return.

#### II. Securities

Cash, however, is not the only way to make a current gift. Though you may not have an acre of pine trees or a wagonload of corn to give, you may have other resources besides money. More than 32 million Americans own securities (stocks, including mutual funds, and bonds). Many of these people have philanthropic interests and are using their securities as a means of giving. They are giving securities in three ways. You may want to give in one of these ways:

First-give directly to the

charity or institution securities that have held for six months or longer and have appreciated (gone up) in value. This offers you two tax advantages: (1) You can deduct the current fair market value of the securities, and (2) you avoid all capital gains taxes.

For example, say you bought 100 shares of ABC corporation last year and paid \$1,000 for the stock. Now it is valued at \$2,500. When you give the stock itself, you deduct \$2,500 on your federal income tax return. You avoid the payment of capital gains on the \$1,500 increase in the value of the stock. This can mean a tax saving of as much as \$375.

Gifts of appreciated securities are deductible up to 30 percent of your adjusted gross income. So, if you have appreciated securities, consider using them rather than cash to fulfill your charitable intentions. You can afford to give more by giving appreciated securities outright, because of the tax benefits.

Second—give the gain. You give the capital gain instead of the full value of the stocks. This is called a 'bargain sale'—you actually sell the stock to the charity for its original cost and deduct the difference as a charitable gift. You will probably incur some capital gains tax, but you will also receive an income tax deduction.

Third—sell securities that have declined in value and give the proceeds. Securities that are worth less than you paid for them entitle you to take a capital loss on your federal income tax return. If you give the securities directly to the charity, you cannot take the capital loss on your tax return. You still receive a tax deduction for the value of the cash you give, however.

Suppose you had paid \$1,000 last year for securities now worth only \$800. If you gave the securities

outright, you would receive an income tax deduction for \$800, period. But if you sold the stocks for \$800 which you then gave to charity or to a nonprofit institution, you would receive a deduction for the \$800, and in addition, there would be a \$200 capital loss when you sold the stocks, which you may declare on your tax return.

## III. Life Insurance

Life insurance policies that you no longer need for a child who has completed his education, a mortgage which has been paid, or for family protection because of business success make excellent charitable gifts. If the policy is fully paid up, you may deduct its replacement cost. If premiums are still being paid, the approximate cash value is deductible, plus all future premiums you pay. Your life insurance company can tell you the exact amount you can deduct.

#### or

You can give your policy dividends by assignment. The policy dividends you receive are not reportable by you as taxable income, but they are deductible when you give them.

#### or

Take out a new policy naming the institution as owner and beneficiary. It is a way to assure a very substantial gift at a relatively small monthly cost—the "installment plan," you might say. The premiums are deductible on your federal income tax return.

## IV. Gifts in Kind

Suppose you do have that acre of pine trees, or that crop of corn, or livestock, or a coin collection, works of art, jewelry, antiques, royalties, inventories, etc. These are still valuable items of exchange which institutions welcome and appreciate as gifts.

#### V. Real Estate

Many people have a great deal

of their resources tied up in homes, farms, ranches, rental property, commercial property, resort property. These as gifts should be discussed in advance with a representative of our organization.

#### VI. Memorial Gifts

Often families, respecting the wishes of deceased loved ones, request that memorials be sent to a favorite nonprofit institution in lieu of other remembrances. Such a tribute is appropriate even in the absence of a public request and, unlike other gestures, a memorial contribution lives on in service to other people.

VII. Corporate Giving

If you are a major stockholder in a closed corporation, consider letting your corporation do some of your giving. A corporation can give up to five percent of its taxable income to nonprofit institutions and deduct it.

Gifts of overstocked inventory are also tax deductible at cost basis.

## Who Cares About Tax Advantages?

"I don't give because of tax benefits," you may say. "That's not my purpose at all."

Of course not. If it were, you would be better off keeping your money and forgetting about taxes.

You give because you are concerned about others and the world around you. But tax benefits are intended to be used; that is why they were created in the first place, to encourage charitable giving.

## Give More Than You Can Deduct This Year

If you want to give more this year than the 50 percent you are allowed to deduct, you can carry over the excess into the five succeeding tax years. In this way you can give from an unusually large income and still be able to claim the tax deduction over a period of years.

## To Whom Should I Give?

The Bible Sabbath Association International is worthy of your prayerful consideration. The continuance of our worldwide ministry is dependent upon your liberal love gifts.

At this time of the year it is not unlikely that one's mailbox might contain several appeals in the same week. You might see anything from a glossy four-color pamphlet to a handwritten postcard. How do you decide?

We all have our priorities—what we consider the most urgent cause or what will, in the long run, have the most important effect. That is the first consideration. What do you want to accomplish by your gift?

Only after you have prayerfully considered the far-reaching consequences of your gift to the Bible Sabbath Association International, then make sure it reaches us before January 1, 1977.



## U.S. Supreme Court Upholds Sabbatarian

On November 2 the U.S. Supreme Court upheld, in a 4-4 decision, an appeals court ruling that Parker Seal Company had violated a section of the civil rights law when it discharged Paul Cummins, a supervisor at its Berea, Ky., plant. Cummins had refused on religious grounds to work on the Sabbath after he joined the Worldwide Church of God.

The effect of the tie vote—with Justice John Paul Stevens not participating—is that the lower court ruling stands, but no precedent that can be applied in other cases is established. The two-sentence announcement gave no clues as to how individual justices voted or why Justice Stevens did not participate.

In arriving at the decision the justices relied on a 1972 amendment to the Civil Rights Act that had been introduced by Senator Jennings Randolph (W. Va.), a Seventh Day Baptist.

In a similar case which came to the Supreme Court from an appeals court in Cincinnati, Ohio, in 1971, the justices had ruled in favor of the employer, the Reynolds Metal Company.

Jay Siegel, a labor law specialist who represented the Parker Seal Company, expressed dissatisfaction with the decision, saying that it "really throws it into a no-man's land" and that one could take his choice of the two conflicting

decisions.

Other similar cases now pending are complicated by labor union agreements. One concerns a TWA employee in St. Louis, Mo., who refused Sabbath work. Other cases were started by employees who had been discharged or demoted because of their belief.

The justices have agreed to rule on the TWA case.

## WOWO Manager Talks on Hoosier Blue Laws

Warren L. Maurer, general manager of WOWO Radio, Fort Wayne, Ind., broadcast an editorial on October 2 and October 3, 1976, in which he said:

"Thousands of Indiana residents break the law every week and probably don't even know it. They break the law by going to work, going hunting, or even by mowing the lawn or washing the car. Most of us frequently break this law by working, hunting, or engaging in common labor on Sunday. That's right. Indiana's Sunday closing law, enacted in 1905, has never been repealed.

"There are a few exemptions to Indiana's law forbidding most kinds of work on Sunday. You can legally work if you convey travelers, keep a toll bridge or toll gate, operate a ferry boat, or publish or distribute news . . . at least the WOWO news department seems to be safe. Another interesting

exemption in the law allows you to play baseball or hockey on Sunday as long as you do it after 1 p.m. and more than 1,000 feet from any

church or hospital.

"Although Indiana's Sunday closing law has been on the books for 71 years, enforcement has been pretty spotty. In fact, the last time authorities in northern Indiana seriously tried to enforce the law was in 1967.

"WOWO thinks the 1977 Indiana General Assembly should repeal the Sunday closing law. Even though the law has not been enforced lately, it remains to be used by an over-zealous police department or prosecutor.

"Let's repeal it and save

everybody a lot of trouble."

## Sunday Sales Soar In Alabama Stores

Cash registers as well as church bells are ringing each Sunday in Alabama these days, the result of a ruling last year by the Court of Criminal Appeals that Birmingham police were being discriminatory in their enforcement of the city's

Sunday sales laws.

State blue laws prohibit food stores from being open on Sunday, but larger cities may pass local laws which supersede the state law in allowing stores with four or fewer employees to open on that day. Since the legislature failed to define clearly what it means in providing exemptions, enforcement has led to confusion. Courts have either skirted the issue or let the laws stand in most cases.

A spokesman in the attorney general's office expressed doubt that there would be any change of the laws in the immediate future, but there seems to be a growing acceptance of Sunday shopping

among many Alabamans.

One Sunday shopper said, "If they sell it during the week, I think you should be able to buy it on Sunday."

Another one who does most of her grocery shopping on Sunday, feels that "those people who don't want to shop on Sundays don't have to." And one Birmingham housewife stated, "Church is over and it's convenient for me to shop on Sunday."

Rabbi Moshe Stern of Birmingham said, "I wish more stores were open on Sunday. Then I could tell them [my congregation] they no longer have any excuse for not coming to synagogue on Saturday, because they could work

on Sunday."

Often, what day is considered sacred depends on what culture predominates in a country. "In Israel," Rabbi Stern said, "Christians and Arabs alike have to work on Friday (Sabbath for the Moslems) and Sunday (Sabbath for

the Christians)."

A mellowing attitude is shown even among Protestant ministers. For instance, Rev. Robert A. Larson, pastor of a Presbyterian Church in Birmingham, said, "I have mixed feelings about blue laws in general. Really, it ought not be necessary to keep stores open at all on Sunday. But I feel we should not impose our beliefs about blue laws on Seventhday Adventists, Jews, or even those who have no commitment to church."

Alabama is one of about thirty states that still have laws on their books which regulate Sunday activities. Most of them are not rigidly enforced. In many states the laws are under severe criticism, with such chains as Sears, Penneys, and Montgomery Ward often opening their stores on Sundays. The National Association of Food Chains reports that about half of the nation's supermarkets open on Sunday.

Following World War II and the Jewish holocaust in Europe, a group of Christians decided that something should be done to let Jews know that Christians are not opposed to Jewish people. Thus a Christian community called Nes Amim was established in Israel.

In Nes Amim these Christians began to develop a cordial relationship with the neighboring Jewish kibbutz, which is comprised of survivors of the Jewish holocaust. It took some time, but they are being more and more accepted in the surrounding Jewish communities.

In recent months the community changed its day of worship from the traditional Sunday to the seventh-day Sabbath, Saturday. Their village minister, Shimon Schoon, says that even the Orthodox rabbi now receives him for discussions.

Those of us who observe the Sabbath prayerfully look forward to seeing more and more groups begin to practice the teachings of the Bible concerning the Sabbath. Even though this group began observing the Sabbath in Israel for convenience sake, we believe it is an example of the work of the Holy Spirit to bring the message of the Good News of Yahshua the Messiah to the Jewish people. #### DIAL-A-WORD-FROM-ZION

A telephone recorder is used in a telephone ministry, called Dial-a-Word-From-Zion, which has been initiated in the French Lick, Ind., area. By calling (812) 936-2590 people can hear recorded messages that are changed daily. Some are in the form of one to two-minute sermons: others are inspirational messages in song. The purpose of this ministry is to reach ones, such as shut-ins, who are not able to attend services and to have inspirational words available to everyone 24 hours a day. Some like this ministry because it is a way they can listen to comforting words and yet have a private devotion at the same time. It is sponsored by the Zion College of Theology, a Sabbatarian organization in French Lick.

## PILGRIM ACRES SCHOOL

While driving down a dusty country road in East Texas near the little town of Emory, one comes upon a small community of Sabbath-keeping believers who put a high premium on the education of their children. Just this fall they inaugurated the Pilgrim Acres School.

Under the direction of their church pastor, Elder Paul Wilds, this school is now functioning smoothly with 30 pupils in attendance. The bulk of the teaching is by Patricia Adair, with help from other members of the assembly. Many of the children live with their parents in homes on property adjoining the assembly building and schoolhouse which are used for camp meetings and special meetings also.

Instruction is given in the Bible, with worship, prayer, and Bible reading emphasized. The textbooks which are used for secular subjects are Bible oriented. Being only in their first year, they are praying for

guidance for the best methods of operating the school for the spiritual and intellectual growth of their children.

## SCHOOLS TO MERGE

Dr. Daniel Knapp has joined the faculty of the Alaska Christian Bible Institute in Houston, Alaska, as dean and will teach Hebrew, exegesis of John, English, and church history. Dr. Calvin C. Hartman, president of the school, will teach Old Testament survey, Psalms, and Christian education. Ana Knapp will be joining the faculty in February as professor in Hebrew. She will also be teaching the course in the Book of Daniel.

Zion College of Biblical Studies, the school that was begun by the Knapps in 1969, is going forward too. Sister Knapp is presently remaining in Vancouver to continue that work. One of its original students, Elmer Varner, has gone to Alaska to continue his education and to work toward the Bachelor of Religious Leadership degree. Brother Varner was the first official student of Zion College. He studied the Hebrew language. Now he is continuing his work in Alaska.

Christian Alaska Bible Institute and Zion College of Biblical studies are contemplating a union. Neither will cease to operate as a unit, but both will continue independent of each other and will seek to cooperate as fully as possible. Both will have the same curriculum in the future, Dr. Knapp and his wife will be on the board of trustees of the institute and Dr. Hartman and his wife will be on the board of directors of Zion.

Drs. Hartman and Knapp both graduated from Pacific Bible Seminary—Hartman with the M. A. and Knapp with the Th.B.

## The King's Work

The King's Work is a newly formed agency of professional radio announcers who are all Sabbatarians and who desire to obtain more and more radio time for all Sabbatarian churches. They are interested in working with all who already have radio programs, no matter how large or small, and also with those who have not had the opportunity in the past to have a radio ministry. They would even be available to supply announcers for any church that would want to start a radio ministry, as long as it is Sabbatarian.

Although a new organization, they already have contacts with several stations throughout the United States who are interested in selling time to churches who have quality religious broadcasts. And being Sabbatarians themselves, they are going to be quite concerned to obtain the best times on the best stations at the lowest possible rates.
