
#### Good News Magazine

### THE MESSAGE DELIVERED TO SAN PABLO

SAN PABLO CITY--"Is your husband a lawyer?" a priest asked. "What made you think that?" Mrs. Adair asked in reply. "He would make a good preacher," the priest answered. "Thank you. In fact he is a minister," chuckled Mrs. Adair.

That best described the impact of the 14th PT Lecture given by Mr. Colin Adair to the people of San Pablo City last July 31 at the Canossian College Auditorium. For the first time, almost the entire staff of a Catholic college led by an Italian Mother Superior and Filipino nuns attended the lecture. DZSP Radio beamed the entire lecture to Laguna province and to most of Southern Tagalog region. After the speech, the priest and the nuns surrounded Mr. Adair and thanked him "for bringing the gospel to our city," while lamenting the fact that only 90 persons attended.

Prior to the lecture, Mr. Adair spoke to the San Pablo City Lions Club, composed of leading city government, civic and business-

He preached to them a men, facet of the gospel in his subject "Your Marriage Can Be Happy". He said "the Creator God instituted the human family to insure the survival of the human species." He asked "What is a nation but a family grown big? Strong families mean a strong nation. And this is what Pres. Marcos is trying to build in the New Society." After the lecture Lions President Jule Tosino thanked their guest and awarded him with a Certificate of Appreciation.

While still at the Lions, Mayor Cesar P. Dizon sent his PRO to pick up Mr. Adair. For 35 minutes the Mayor, the City Council and the Barangay heads listened to Mr. Adair as he explained why he came to San Pablo City. He expounded at length on the Ambassador College Educational Extension Program, "Dr. Armstrong always stresses the matter of cause and effect in every social problem. While others treat the effect, we at Ambassador College work at the cause. Only by striving for the right causes can we eliminate a lot of our social ills." At this point

In his talk he challenged his audience to speak out against any form of immorality in the media which may negate what moral values they are teaching to their students. "But the responsibility of teaching morals to the children belongs not to you - but to the parents." Then he hammered the need for the Moral Code called "The Ten Commandments". "What's religious with 'Thou shalt not lie', What's wrong with 'Thou shalt not kill', what's religious with 'Thou shalt not steal?. Nothing! In fact the absence of these basic human values are the main cause of a lot of our troubles today."

Then he gave the key to teaching moral values. "It's not enough to say 'don't do this or don't do that' - tell them the reason why. Explain why one should not steal. Ask them 'would you like (Continued to page 8)

MANPOWER DEVELOPMENT PROGRAM DRAWN UP

A plan designed to develop future leaders, deacons, administrators and ministerial candidates has been completed. Officially called Manpower Development Program, it takes on greater significance when one considers the bright prospects of expansion of the Work in the Philippines and Northeast Asia,

#### Preparatory

The first part of the Manpower Program will consist of Developmental Courses: one for undergraduates, another for college graduates (sub-professionals) and a third for professionals. Each group will be limited to 30 church members but in no case be less than 15. Subject blocks include human relations, communications and elementary Bible studies. (The present Bible class will be dissolved to avoid duplication.)

The Developmental Course, scheduled to start after the Feast of Tabernacles, require a total of 68 training hours spread over a period of 17 weeks,

#### Training Proper

From among the graduates of the DCs will be selected the participants in the Leadership Training Course (LTC). (By the way, the experimental Leadership Training Course ended just recently with 15 graduates.) The criteria will be speaking ability, biblical outlook, and especially attitude, interest and availability. Subject blocks consist of leadership development and communications, and management. It is hoped that those who finish this first phase of training in three months can capably take charge of church activities such as sports, socials and entertainment.

Phase 2 is Supervisory & Management Course (SMC), LTC graduates who have shown potential as administrative assistants whether on the payroll of the church or not and ministerial candidates will qualify to take the course which will take some 50 training hours.

Prospective ministerial candidates who have finished the SMC will be participants in the third training phase: Ministerial Bible Course (MBC).

#### Trainors

To complement the Manpower Development Course, a Trainors' Course has also been set up, Subject blocks include psychology, communications, gists of the LTC, SMC and the MBC, subjects and (Continued to page 8)

### NEW DISTRICT NUMBERS GIVEN

MANILA-The "only permanent thing in this world"--change--has happened again! Colin Adair, Regional Director of the Church here, recently informed the district coordinators about the change in the numbering of church districts in the country.

In a memo dated July 15, Mr. Adair said: "We have . . . revised the district numbering to conform to the regional grouping being used by the postal system. Through this grouping we have been able to pinpoint communi- Hood. cation centers where we will focus the main thrust of the Gospel Work as a priority."

Except for the former District 3, all other districts retain the same boundaries. The district is now broken down into three separate districts: District 3 (including the provinces of Zambales, Bataan, Pampanga, Tarlac and Nueva Ecija and all their cities), District 4 (including Metro Manila, Rizal, Cavite, Bulacan, Romblon and Palawan and all their. cities), and District 4a (including Laguna, Batangas, Quezon, Marinduque, Or, Mindoro and Occ. Mindoro and all their cities).

Can you imagine God's Church existing without the usual organized, churchwide social activities like outings to scenic resorts, blissful summer dances, envigorating sports tournaments, sociabilityenhancing parties and clubs for the children, young adults and elderly alike - activities that not only develop personality and give personal enjoyment but, more importantly, provide a medium of fellowshipping and characterbuilding with your fellow Christian? Can you imagine the lackluster, lackadaisical physical existence you would have if all Church activities are confined just to the spiritual? How about a Feast of Tabernacles minus the usual wholesome, pleasure-giving get-together family night, dance and entertaining stage shows? How or where could you have them if the Church didn't organize such activities?

A Christian's life involves proper balance - a balance of everything affecting his physical, mental and spiritual well-being. And that is the reason why in the Church organization, there is a

non-pastoral group of activities which is designed to make a Christian well-rounded.

In organizing social activities and entertainment cost, needless to say, is involved though the cost should never be confused with the value of such upbuilding activities. For instance, stage show preparations require initial expenses in props; so with arrangements for dance halls, acquiring our own sports paraphernalia, etc. And the Church has had no funds specifically and distinctly for socials. In the past, Church income had been used to bear certain expenses and there have been cases of organizers of certain activities having to grapple with the problem of liquidating expenses long after the activities have been

In order, therefore, that expenses for social activities will not have to eat up Church income (which must go to the preaching of the gospel) or bring about a problem of liquidation, it is necessary to establish a SOCIAL DEVELOPMENT FUND. Raising the SOCIAL DEVE-

LOPMENT FUND is a continuous, year-round process, Funds accumulate, then are depleted as expenses for a particular activity are withdrawn and then are built up again.

The idea is to have funds donated monthly by members who, by their own volition, have decided to share their extra centavos, extra pesos, or even extra hundreds of pesos in support of these necessary activities. A donor will sign a "statement of support" in which he indicates how much he intends to give monthly. No one will be compelled to be a donor. ## MY HOME BARRIO--ERODED AND WASHED OUT!

On May 25 this year (coinciding with the day I was born in 1916) my wife and I with three other Pangasinan brethren were at our church resthouse at Bacag, Villasis, Pangasinan-all stranded due to the flood. We were listening to the radio about typhoon "Didang" and the flood which was raging fiercely and violently over Central Luzon, when we heard Barrio Salingcob of San Nicolas, Pangasinan was in need of help for evacuation. The floodwaters were eroding the barrio, washing away lands and houses. I stood up and commented: "No, this could not happen, I do not believe itl "Barrio Salingcob, San Nicolas, Pangasinan was the place where I grew up and reared my children, where my parents, my brothers and sisters were then living. Barrio Sanglicob had been on higher ground and never in all my life had it been under floodwaters.

In Baguio about a week earlier, we had heard news that typhoon "Didang" was nearing Eastern Luzon toward Pangasinan, Benguet, and La Union. But it did not come immediately. We only had little rain. Two days before the Sabbath (May 22) Mrs. Ortiguero and I were already on our way to Manila to fulfill my speaking engagement there. We stopped in Pangasinan to visit some brethren in Urdaneta and in San Nicolas, my hometown. At that time the weather was not so bad. It was raining but no typhoon. According to the radio, typhoon Didang was already in Manila. We were doubting if we would proceed to Manila or not. We prayed and observed the weather. We stayed at our church resthouse at Bacag until Friday night but when we woke up early in the morning, it was clear. So we proceeded to Manila to catch up with the 1 P.M. Sabbath Service.

the provinces of Tarlac and Pampanga, the highway was not Bulacan it was different, It was many of the streets were flooded and we had a hard time reaching the church meeting place. We were late about twenty minutes for the Sabbath service. We entered the hall during the sermonette. There were about 500 sincere and brave brethren who attended the service that day. gave the sermon and we had a happy time fellowshipping together although outside the hall the typhoon was raging hard.

On returning to the province the next day (Sunday), at the toll gate of the North Express Highway, the highway patrols warned us not to proceed due to flooded areas on the highway. We

decided to proceed anyway. Fortunately the highway was passable and we arrived at our Bacag Resthouse.

On that night of our arrival in Bacag and until May 25 it rained harder and harder. With the howling winds we knew it was typhoon Didang. All we heard from the radio was about the typhoon and flood destroying everything in its path. The towns of Bayambang, Bautista, Alcala, Urbistondo, Lingayen, Dagupan, Rosales, Tayug and San Nicolas were under water and badly affected.

It was at this time we heard about Barrio Salingcob being eroded and washed away. We sighed with regret that we were not able to visit immediately those places affected where we have brethren. Also at our Bacag Resthouse water was all around and the highway was impassable no vehicle seen anywhere. We were cut off from all communications to and from brethren, No telegram, no message received from brethren.

Only after the first week of June, when we were able to visit San Nicolas, did Mrs. Ortiguero and I see with our own eyes and believe what we had heard over the radio. Barrio Salingcob was indeed eroded and washed out!

river (formerly the barrio site) with the help of some barrio residents, viewed the destruction and talked to our folks, relatives and friends. All the lots, houses and farmlands of my parents, brothers and sisters in the flesh, together with my son Abraham's riceland that I gave, were lost and gone. The whole barrio with about 200 houses was gone. Among its dispossessed residents are our brethren in the faith - Mr. and Mrs. Saturnino Bagabag, who have nine children.

interviewed Mr. Bagabag per-On our way to Manila, passing sonally & asked him to describe how the flood affected them. He said, "We are small farmers and we flooded, but when we were in owned two parcels of land; one is where we had our house which is raining hard with strong winds, 4,000 square meters and the other and upon our arrival in Manila, parcel is more or less one hectare. These were irrigated rice lands.

> "At 9 A.M. of May 25 my wife and two of my children were with me on our land three kilometers away from our house and situated along the river upstream. We were working on the farm when the river (Ambayoan River -- tributary of the Big Agno River) rolled and began to overflow its banks. I thought of our children at home. I advised my wife to remain behind, saying I would return after advising the children on what to do. raced that three kilometers distance. As I arrived home I found my children and instructed them to evacuate to our neighbors immediately. So they did and I

left and returned to where my wife was. On my way about a kilometer the river overflowed its banks, with water crushing all around my path so that I had a hard time wading to the higher ground. I didn't know where to go - whether to return home or to. proceed to where my wife and two children were.

"The water ran very fast. Lower grounds were flooded and as I returned to where my wife was, our land was covered with water and bamboo trees falling down and being washed away. We ran home and found our children safe and our house still standing with our neighbors but we could not reach it anymore -- water was surging all around. Some of our neighbors were brave and swam to salvage what they could, but were stranded on the other side of the water....

"We watched our house as a huge uprooted bamboo tree which was floating crashed into our house, and in a minute our house and all our belongings floated away, all gone. So with our neigbors' houses. We thank God

we were safe.

"We lost all the provisions we had and my wife and I are harvesting damaged rice at a friend's second crop harvest and our share is for our food. We are staying temporarily at our mother's house which is at the outskirts of the barrio and we don't know where to go and stay permanently."

Mr. Bagabag lost a total of around thirty thousand pesos (P30,000:00). I offered him some assistance - used clothing and little money (P-200.00). He and his family need to be relocated.

Another typhoon ("Juaning") hit Central Luzon recently and what little remained of barrio Salingcob was completely eroded and vanished. The inhabitants fled to the hills nearby and have started a new beginning.

There were other members in Pangasinan who suffered. Their houses were flooded but were not eroded and washed away. They suffered from lack of food and some got sick. We thank the Lord no one died. Had the flood come at night in Barrio Salingcob, many people could have died.

City (Baguio) by some people.

It has for years been drawing countless Fillipinos and foreigners who keep coming back to revitalize depleted energies, mainly by partaking of the healing waters of Mambucal's medicinal springs.

Tall trees, clinging vines, moss covered rocks, cool springs, lush vegetation and flowering shrubs remind one that here is nature at its best. And the singing of birds pervade the surroundings, making one glad that he is alive.

Just recently, a road clearing has been made that will wind its way up to the summit of the mountain. This will give you a chance to make an exploration that will bring you as high as the summit. To the lover of nature, this will surely bring some delights.

In fact, as one of the features of this year's Feast, there's a plan for a half day hike, a trek to the wind swept summit, where from this vantage one can scan the horizon. This will serve to acquaint us with the magnificence of God's creation; what with all the variety of flowers and greenery in great abundance,

To gather additional firsthand information that will help us plan for the Feast, a visit to Mambucal was made last July 4 by Mr. Roberto Gopez, Mr. Bernardo Castillon and this writer, Cottages were checked, the availability of facilities were verified, and as a whole we were satisfied with the arrangements. As a sidelight, we climbed to the first waterfall to view this wonder of nature. It's beautiful, really. Water cascading past big rocks, sunigiht filtering thru the intertwining branches and leaves-and with the playful sound of chirping birds in the background.

Having our own Feast site here in the Visayas is a big blessing (with the reduction in transportation expenses, this will enable whole families to attend). We consider it a double blessing to have our Feast in a setting as beautiful as Mambucal.

less than the facilities of the new Marcos Sports Center in Cagayan de Oro City have opened for the Feast of Tabernacles in Mindanao. The center was the setting for the national sports happening Palarong Pambansa last year.

Encardio Benitez, pastor of the Bukidnon church and coordinator for Districts 9 and 10, has already made negotiations with officials of the Center. Mr. Benitez, who serves as Festival Elder, enthusiastically described the new Feast site as "Squaw Valley type"—at least in facilities although not in climate by any means.

"The basketball court and the swimming pool and some athletic equipment such as soft ball and volleyball are open to us for just a small fee," Mr. Benitez said. The meeting place for the Feast is the

southern building in the Marcos complex which, according to Mr. Benitez, can hold several thousand people and "is not directly hit by the wind in case the weather is not good." And the hall rent for the entire eight days? Would you believe—P 240 only (at P 30 per day)!

A letter explaining details of the feast arrangements is being sent out to Mindanao brethren. Any others who wish to attend in Cagayan de Oro may write to Mr. Benitez (Don Carlos, Bukidnon) or Edmond Macaraeg (Festival Supervisor, P.O. Box 174, Davao City 9501).

Some 600 brethren are expected to attend in Cagayan de Oro, now in its second year as a Feast site. Last year the Feast was held at the seaside Bulakeña Beach Resort.

## FIRST VISIT TO MONKAYO CHURCH FARMLAND

LUPON, Davao Oriental-District XI Acting Coordinator Mr.Edmond Macaraeg made his first visit June 13 to a church-owned farmland in Ammoan, Monkayo, a two-and-a-half hour bus ride from Tagum, Mr. Macaraeg was accompanied by his assistant Mr. Marciano Moning and this writer.

Ammoan begins where the streets of Monkayo end. We got there via a trail and a banca across the Agusan river. We proceeded to the house owned by one of our members, Mr. and Mrs. Restituto Fuentes, where several brethren had been waiting. Within a few minutes, accelerated by news of our pastor's presence, some more brethren came from the fields and chatted with Mr. Macaraeg right through lunch.

After lunch Mr. Macaraeg and Mr. Moning discussed problems that confront the Church farmland and its maintenance. The climax came when Mr. Macaraeg gave a brief lecture on the very needful and little understood subject of family planning and Church attendance. Because it is a problem among some members, he stressed the importance of planning with regards to spacing and number of children and their education as well as the future that awaits them. He discussed birth control methods and principles without omitting the aspect of love and concern. Family planning not "family planting" was encouraged. There were some smiles from some of us but the formal lesson was learned.

Mr. Macaraeg then discussed the importance and goal of church attendance and the tragic conse. quences when such is neglected Lack of zeal in attending Sabbath services and other convocations as outlined in God's Word and laziness to make every effort to find ways and means to attend, he said, means deprivation from drinking of the fountain of spiritual strength needed in keeping us from slowly drifting from God's truths and ways. He encouraged everyone to attend as much as possible.

The visit to Monkayo, we feel, has 'widened the road of understanding and strengthened the tie between the ministry and the membership.

## BUKIDNON BALIKBAYAN?

DON CARLOS, Bukidnon-Encardio Benitez, pastor of the
Bukidnon church, indicated in a
recent letter to Mr. Colin Adair
that the brethren who left their
homes in San Fernando, this province, after rebel attacks sometime in October last year, may
soon return to their abandoned

Twelve families (totalling about 72 persons) in the Worldwide Church of God had settled in San Fernando, Bukidnon on land bought by the Church from Bukidnon natives. In October 1975 these brethren were forced out from their houses, leaving ripe and nearly ripe crops behind, because of a gunfight that had broken out between native rebels

and government forces. Natives had killed some Christian or low-land settlers in the adjoining barrio in reprisal for alleged land-grabbing. To avert total chaos, government forces stepped in. The innocent brethren were caught in the fighting and escaped death by the skin of their teeth through timely evacuation upon the suggestion by friendly natives.

The displaced brethren have since lived temporarily with other brethren in Don Carlos and other places, some finding temporary jobs. Emergency funds from the Manila head office had been sent to their aid. Prospects for "balikbayan" (return to hometown) had looked bleak, until Mr. Benitez, our man in Northern Mindanao, revisited San Fernando the first week of July.

This report came in the wake of Mr. Benitez' visit with two Bukidnon native chieftains (datus) in San Fernando. They told him that the place is already safe for the brethren to return to. "Tribal war was settled because of the dialogue between the PANAMIN (Presidential Assistant on National Minorities) and the local government," Mr. Benitez was assured.

"We went personally to our brethren's place there," Mr. Benitez said, "And thank God some of the houses are still there. But it is a total wilderness!"

Mr. Benitez was accompanied on this trip by Ernesto Damasco, a recently baptized member from Kisolon, Bukidnon. Mr. Damasco is a Bukidnon native and a former minister of a Pentecostal church in his place. He served as interpreter during the visit. Mr. Benitez hopes Mr. Damasco can head the brethren in their "balikbayan" to San Fernando and to mediate between the natives and the brethren.





















## HOW TO PREPARE COTTAGE CHEESE

Corazon M. Dalusong Dairy Development Division MOD MAGAZINE, Jan. 17, 1975

The utensils and materials required in the preparation of cottage cheese consist of the following:

- Fresh carabao or cow's milk desired quantity.
- 2. Salt salt is added at the rate of 3 percent of the whole milk or 2 tablespoons for every liter of milk used. This should first be dissolved in a glass of cold water before adding into the milk.
- 3. A small enameled container (to hold the milk). This should fit inside a sufficiently big kettle to serve as a double boiler.
- 4. Stove for heating the milk.
- 5. Ladle for stirring.
- 6. Thermometer for checking the temperature of the milk.
- 7. Rennet to coagulate the milk. Follow the manufacturer's direction for use.
- Long bladed knife for cutting the curd.
- 9. Bottomless and perforated wooden mould to shape the curd. (3" x 5 ½ x 5½).

- Metal strainer with a handle for removing the curd from the cooking vessel.
- 11. Banana leaves or wax paper for wrapping the finished product.
- 12. Refrigerator to keep the cheese.
- 13. A working table.

#### PROCEDURE

- Pasteurize carabao or cow's milk at 145°F for 30 minutes and cool to 88°F.
- Add the salt solution to the milk and stir for 5 minutes.
- 3. Then add rennet solution, continuously
  stirring the milk for 2
  minutes to mix
  thoroughly the rennet
  in the milk.

- Cover the milk and allow to stand undisturbed from 30 to 45 minutes or until such time when a firm curd is produced.
- Cut hard by means of a clean long bladed knife into small pieces about a half an inch cube to allow the escape of the whey.
- Leave undisturbed for 5 minutes.
- Gently stir the curd and cook at 98-100°F for 20-30 minutes to render the curd firm and remove the excess moisture.
- 8. By means of wire strainer transfer the curd into bottomless wooden moulds.

  Leave it in the mould to further drain off

- the remaining whey. The curd in the mould is preferably kept inside the refrigerator overnight.
- Wrap in clean fresh banana leaves or wax paper.
- 10. Store inside the refrigerator. This product will keep for a period of one week if stored in the refrigerator and for at least 2 days at room temperature.

NOTE: Sterilize the utensils in boiling water before using, to prevent contamination of the product.

#### INNER RESERVES OF STRENGTH

Last June I was out of circulation. I was only able to listen to the sermon given on the day of Pentecost one month after that holy day. I heard it on tape here at home.

For me the afternoon sermon by Mr. Mirto on that day was somewhat significant, for in a way, I was able to have a firsthand experience (on the day of Pentecost, June 6) on what he touched on briefly at the beginning of his sermon-about inner reserves of strength, which are not the influence of evil spirits, which we have in our bodies which we do not ordinarily use to full capacity but which we sometimes bring into play during critical moments. Situations vary according to individual cases. For example we hear of others lifting heavy objects during a fire and other emergencies.

My case was a simpler one. My trouble started last Sabbath (June 5). After eating breakfast, I had pain in my stomach, and my saliva tasted bitter. I thought I had indigestion. But even after vomitting repeatedly, the pain had not subsided. I began to fast in the evening. The next day (Pentecost) the pain in my lower right abdomen had become severe. I could not move my legs because of it. I landed at the emergency ward of the P.G.H., where a string of doctors continually diagnosed me that day. Later on it was confirmed that I had acute appendicitis.

Having friends who have related to me their experiences after undergoing an operation, I had an lokling of what was going to happen to me at the hospital. Only, my case was a little complicated. I informed the doctor that I was being treated for a lung ailment—a condition which makes an operation a very risky matter. There was the possibility that the lungs might stop working and I knew it. However it had to be done. I underwent an apendectomy at 5 o'clock in the afternoon.

But before that, I had resolved that thinking negative won't help so I had to forget nervousness, despair, frustration, hopelessness, etc. I prayed sincerely to God for help concerning my condition and for my part I had to remain composed (understanding very well that it would take time). And perhaps sub-conciously or conciously I put to use that inner reserve of strength that we have in our bodies to be able to withstand the ordeal. I was very determined and in high spirits. I even thought that it was harder last year when my health made a turn for the worse and I was in bed for several months.

My outlook on medicines and doctors is a little better now, especially after hearing Mr. Mirto's message about his subject when I was then able to attend services once more. Whatever the case, medicines do not take away my faith in God. He is still the Ruler of all things.

TOLOSA, Leyte--It was near my conversion that owning a personal copy of the Bible seemed to be a dilemma. I was so penniless that I couldn't afford to buy the book. of Tabernacles. Some of you have been worried about the new registration fee which is applicable this year. You are finding that with the addition of this amount you discover you have not enough money to cover you expenses. We realize that this will apply to some. However, rather than feel you can't afford to come this year because of this fee, you should simply include it in your total calculations and if you find you are short then you should ask for financial help. As I mentioned in my Feast letter, the registration fee is to enable us to cover all ourexpenses outside of your accommodations. In previous years we have been in the red, with our excess tithes and tithe of the tithe dropping drastically. We can't allow this to continue. We are not, of course, trying to keep you away from the Feast! So please, be sure to ask for help if you find yourself financially lacking. One word about how to apply for help. There have been a few letters from some of you asking for assistance. But that's all you do you just ask! You have not given us details of your problem. So when you ask for help, please be sure to enumerate all your expenses (including travel to and from the Feast site), the amount of money (second tithe and savings) you already have or will have by Feast time, and a balance which if you are seeking help will be the amount you are short. State clearly the exact amount of assistance required. This will enable the Festival Office to properly appropriate the money for you. Remember, we have not unlimited funds for helping you, so first come first served. If you apply too late you may not be able to get help even though you may qualify. When the "bank" runs short of money it closes its doors! I have already received a few letters asking for help but not stating how much help is needed. These letters have had to be returned to the writers unprocessed.

somebody to steal from you or cheat you? or kill you? "Then he concluded, "When you have done this or that and still the problems exist, just be patient because it will not take long now before a better education system will be established in your city."

From the DEC lecture, we proceeded to DZSP for a 30-minute interview hooked up with DWKS and DWAY - the only radio stations in San Pablo City. Mayor Dizon sent City Information Officer Ruben Taningco assisted by DZSP Stn. Manager Resty Azusano, City KBP Chairman, to interview Mr. Adair. Towards the end of the program, Mr. Adair pointed out that "regardless of the color of your skin, nationality, creed or ideology, the number one problem facing all of us today is the question of survival. Will mankind survive the 20th century?"

The next Friday, Mr. Adair addressed the student body and faculty of the two leading educational institutions in the city, the Canossian College and the Laguna Colleges Together over 900 attended. He showed the students the correct method of dating. "You might think that what I'm telling you is old fashloned. But now can it be old-fashioned when only very few have so far tried it?" Based on the questions asked by the students during the open forum, the school officials asked Mr. Adair to prepare another lecture this time to educate the parents.

Saturday, July 31 the PT Lecture took place at the Canossian Collège. The Mother Superior and all college staff congratulated Mr. Adair after the speech for "bringing the gospel to our city." They gave an open invitation to Mr. Adair to come back and address their student body and faculty. (At this writing, St. Scholastica Academy of San Fernando, Pampanga has invited Mr. Adair to give a lecture to their community, as well as to the faculty and student body on his way to 15th PT Lecture in Olongapo City).

Finally on Sunday morning the first Bible Seminar was held at the Music Room of the same college, To the big surprise of everybody the Mother Superior prepared a sumptuous breakfast for the Adairs, "You must be tired driving from Manila. Please accept what we can offer." Altho the Bible seminar was not as good as expected (27 in the morning and 19 in the afternoon including members), still the warm reception of the leaders of the city and even this time from the religious community - was just overwhelm-

methods of teaching.

The course will train people from the Manila Church (not more than 10 and preferably those whose jobs or businessnes require them to travel to other parts of the country) who will assist the District Coordinators in implementing the MDP in their respective areas.

Six training centers are envisioned to be put up to serve the needs of all the 11 districts of the Philippine Work, namely: Baguio City for districts 1 and 2; Manila - 3, 4 and 4-a; Naga City - 5; Cebu City - 6, 7 and 8; Cagayan de Oro - 9 and 10; and Davao City - 11. (Benito P. Yadao, Jr.)
