Hi, Mr. Kubik,

This letter is to explain to you why I went to the trouble of typing out Dr. Hoeh's tapes. I'm trying to help some others to come out of some error that I was fortunate enough to come out of myself some years ago. I feel I have gotten a log out of my eye, and that I can help some others get the splinter out of theirs. I want to explain to you here in some detail what it's all about. You are God's Minister and you certainly should know of it. Certainly I will welcome your comments and instruction about this, because I don't want to do this secretly or do anything I should be doing.

In the early 1970's I fell into studying about the so-called Rockefeller conspiracy, and there were others who also became engrossed in it. We would spend our time before and after services discussing the latest revelation from the publications and books that purported to reveal the secret and subversive activities that Rockefeller was supposed to be carrying out to enslave the world under Communism through the machinations of the Federal Reserve Bank system. I don't know how much you have heard of it, so I don't know if I'm talking about something you are unaware of. Suffice to say that the conspiracy buffs will believe anything published that accuses the Rockefellers and the world banks of enslaving the people. They reject out of hand any evidence that the theory may be without proof.

The first write-up I made that you brought to Dr. Hoeh was based in part on the conspiracy theory. He explained that he doesn't believe Satan gives men the great power that is necessary to carry out a world conspiracy. He divides to conquer instead of uniting men in one physical government. As time went on I began to realize that by agreeing with these conspiracy buffs, I was accusing political leaders, particularly American leaders, of heinous crimes for which nobody offered good proof. I wasn't praying for them, as God instructs. If I followed their policies, I would eventually refuse to pay my taxes and would not render to Ceasar what was his due. There came a point at which I decided to try to get to the bottom of the thing. I wrote to some 28 different societies and groups that claimed to have the inside track on what was really going on.

I got back in the mail a hodgepodge of stuff that showed clearly there was no consistency to their reporting or their theories. They really didn't have a handle on things. One day I simply decided I was all wrong in studying into these things, that it was time to begin dwelling on God's Truth. We sold all the conspiracy books, got a good price for them. I tried to show my buddies they were wrong in this thing, but to little avail. Over the past few years I have seen to it I've had only occasional contact with them, because I just don't believe the stuff. On the contrary, as time want on I began to find good reasons to refute the idea, not only in God's Word, but in business publications.

When I ran across the tapes by Dr. Hoeh, the idea began to form that maybe here was a way I could picture clearly for these people what the facts really are about the way the world is run, and then add a footnote to point up the fact we are to pray for world leaders, not accuse them. God says He puts the leaders in place and takes them down. The fact that Mr. Armstrong announces to world leaders what is coming, and that he goes to considerable effort to do it means to me that God is doing what He says He will do in Amos 3:7, He will tell His servants what is to happen.

This identifies these leaders as God's Servants, I think. It was this realization that I was accusing world leaders of things for which there is no proof, and that these are God's servants that finally jarred me to get the log out of my eye.

I typed out those sermons so I could add the footnote to bring this same thing out. Maybe it will bring them to see the error of their ways, too. It will probably take some time before they will begin to realize it, too. Maybe this was a clumsy way to go about it, but if it will help them to see the truth, it was worth it. Nothing else has worked.

When you have familiarized yourself with it, if you have any comments or instruction for me, I'd like to hear it. You are God's Minister and you have the authority in these matters. The last page has the footnote I added. If I'm in error, I should know if it.

I've tried to do this in sinch a way they are not offended, that my real purpose is not shown. Time will tell if it was effective.
