JUST WHAT IS MY PLACE IN THE WORK?

In the Pastor's Report of April 17, some statements regarding myself were made, with the best of intentions, designed to refute the false rumor started by, regretfully, my son, that I am senile, my mental and other faculties failing, and that I no longer head the Work -- and indeed he falsely claims I don't even know what goes on at HEADQUARTERS.

Fellow ministers, most of you sat before me during the Ministers' Conference -- you have, or SHOULD have unless dilatory, observed and heard ample evidence that my powers of leadership in this Work HAVE NOT DETERIORATED. In fact, I have continued to GROW in grace and the KNOW-LEDGE of our Lord Jesus Christ.

In order that the brethren, as well as the ministry, might KNOW that my son's false accusation is a lie, I spoke, by prerecorded video tape, at EVERY Feast site, both on the opening night, and the first Holy Day morning.

I have been producing MORE WRITING than ever before in my life -until some ministers have said I write almost faster than they can keep
up with me by reading what I write -- in The PLAIN TRUTH, the GOOD NEWS,
the WORLDWIDE NEWS, the PASTOR'S REPORT, regular and even more frequently
than usual, Co-Worker letters, beside working on FIVE FULL HARD-BOUND
BOOKS to go into bookstores around the world.

Yet I sometimes wonder if some of you ministers have been "turned off," by such false accusations or your own ego and prejudice, from READING what the human head, UNDER JESUS Christ over the whole Work, has written for YOU to read. IF there are any such the Living Head of this Work will reveal it to me in His due time, and appropriate action will be taken.

Let me here quote a portion of the Pastor's Report of April 17:

Quote: "Some ... (even a few ministers) have claimed that Mr. Herbert W. Armstrong is cut off, isolated from the ministry, having little or no contact with them."

Comment: I don't believe that either members or ministers claimed that. But my son Garner Ted did spread the rumor, and some, supposing all people begin to deteriorate mentally past age 60, have "swallowed" the false rumor. Just this morning I saw a newspaper report that Henry Ford II is now retiring at age 62. I have NOT retired -- I do not personally believe in the American custom of retiring, and I am no more "senile" in mind than I was at age 49 -- Garner Ted's age. In fact, his current writings show that it is he, not I, who is becoming senile of mind.

But to continue the quote from the April 17 Pastor's Report: "Mr. Meredith usually contacts Mr. Armstrong at least two or three times a week. Mr. Ellis LaRavia, Mr. Rader, Dennis Luker, Sherwin McMichael, myself and others also have regular contact with him."

That is sufficient to show what I mean -- one could gain the impression that the Church and all the Work is being run from Pasadena, and that those in charge -- those at the HEAD of the Work, are in touch with Mr. Armstrong, and keep him informed on what THEY decide!

The writer did not mean to convey that impression, yet I am convinced several got that impression. Let us GET THIS STRAIGHT! JESUS CHRIST is the HEAD OF THIS CHURCH. His Headquarters now are at the throne of God the Father in heaven. Earthly human headquarters are WHEREVER CHRIST'S APOSTLE IS -- whether at Tucson, Tokyo as it was last week, or Pasadena. Actually "Headquarters" is not a PLACE, a BUILDING, or a CITY. It is the one IN CHARGE! Since a year ago, I have again taken over complete charge of the entire Work -- Church, College, Foundation.

Do I thus exalt myself, as some accuse? NEVER! Far from it. My son Ted has said that HE, Ted, built the Church and the Work. I apologize for him. JESUS CHRIST, the HEAD of this Church, built it. He used me, starting when Ted was a little child three years old. My son Ted tried to water down God's TRUTH. He caused Christ to withdraw His blessing, and has tried and is trying to DESTROY the Church of GOD! But CHRIST is ALIVE -- the HEAD of this Church who BUILT IT, and He has chosen me as His earthly apostle and leader IN CHARGE! I do not exalt myself -- I exalt Jesus Christ, but HE has put me in charge, here on earth, UNDER HIM!

Just what IS my place in the Work?

Let me tell you what is my place in the Church -- and the entire Work of God on earth.

More than 52 years ago, God put me through a traumatic experience such as few on earth have ever gone through.

He CONQUERED me. He showed me that His TRUTH was the precise OPPOSITE of what I had been taught and believed. He swept my mind CLEAN of every idea, belief, or teaching EXCEPT HIS TRUTH AS MADE CLEAR IN THE BIBLE! He converted me in a thorough manner few if any others have experienced. He brought me through a REAL repentance, a firmly established faith, and then He by His grace gave me His Holy Spirit, and with it the divine FAITH OF JESUS!

Then He caused others with whom I was fellowshipping (but not joining) to open the way for me to preach six nights a week in a small one room country school house near Eugene, Oregon. Following the 6-weeks' meetings, I organized those converted into a local Church of God -- 19 members.

We were a SPIRITUAL ORGANISM -- not a human organization -- but we were organized on God's pattern. After two more such extended meetings I appointed two as elders, beside myself, and two as deacons. We were not incorporated for a few years, but we were an organized Spiritual Organism.

Radio opened to me. I had planned to publish a magazine called The PLAIN TRUTH. After radio opened to me, the way was opened February 1, 1934, to publish this magazine on a mimeograph.

The Church and the Work GREW -- 30% a year for 35 years. GOD BLESSED US GREATLY! By 1946 God showed me the need to establish a college where young and up-coming ministers might be trained. There was no money available for it -- just as there had never been sufficient money for anything -- and all was done on sheer FAITH -- that FAITH which God GAVE me through His Holy Spirit. In due time there was a college established in England, and one in Big Sandy, Texas.

Just what IS my place in the Work?

God STARTED IT through me. He used me in founding Ambassador College. He has used me in starting and MANAGING The PLAIN TRUTH, the GOOD NEWS -- EVERY FACET OF THE WORK. I never JOINED this Church -- God started it through me. Christ, as living HEAD of the Church and Work, has used me as His chosen Apostle. No member is still living who was a member when the Church (Philadelphia era) was founded. The Church STARTED with me, and my wife Loma. Actually, for seven years, we were the only members of this Philadelphia era. We alone kept all the annual Holy Days. We did fellowship (meet with) those of the Sardis era -- but never "joined" them.

Jesus Christ STARTED this present era of God's Church through me. On the human level, I have ALWAYS MANAGED IT, since the present era started.

Christ, as Head, has never raised up another Apostle. He still heads and RUNS the Church and all its Work through me.

I am, by force of circumstance, the chosen Apostle, and only and sole HUMAN leader of this Church and its entire Work.

NO MAN, or POWER of man, put me in charge of this Church and Work and NO MAN OR POWER OF MAN CAN PUT ME OUT! The authorized, though unconstitutional and illegal POWER, of the largest State in the Union TRIED to put me out.

THE RECEIVER FAILED! He resigned! The Courts, hostile to the Work of the Living God, have not appointed any further "Deceivers." I hope this makes clear my place in the Church.

A TAPE OF A PHONE CONVERSATION MAY MISLEAD

In the April 23 Pastor's Report is a statement about Mr. C. Wayne Cole having illegally taped a private telephone conversation with me.

As I remember it, I had asked or gotten word to Mr. Cole to go to a private telephone where there would be no danger of the telephone having been "bugged" or someone listening in over our own Pasadena exchange.

The item in the Pastor's Report mentions the taped copy had been spliced, edited, portions deleted, parts put together so that they said -- and IN MY VOICE -- things which might be totally contrary to what I said and meant.

This reminds me of a comedy tape which I taped from a record sold in music stores some ten years or more ago.

In it, four well-known news announcers asked questions of Former President Eisenhower, President and Mrs. Johnson, then-Governor Rockefeller of New York, Robert Kennedy, and Richard Nixon. They took portions clipped from tapes of public speeches made by these famous men, putting their own questions before clipped and edited portions of the public speeches. It was a prize example of how a tape may be edited to say just the opposite of what the speaker actually did say.

As near as I remember, I will here give you a few portions of it.

A newscaster asked: "General, if you were President again today, and World War Three would suddenly break out, what would you do?" Then came unmistakably Gen. "Ike's" voice saying, "Well, uh, I uh, I uh, I certainly would not publicise it!" (Much laughter followed on the recording.) They also asked Gen. Eisenhower how long he had been nettled by former President Truman. Mr. Eisenhower's voice came out, "From the first day I knew him until this very minute!" The reporter then said, "Did you know Mr. Truman is coming to Washington next Monday?" Mr. Eisenhower's voice said, "I'm leaving Washington Sunday!"

They pretended to ask a question of President Johnson, then in office. "Mr. President," asked a reporter, "When you had a very slight cold several days ago, did you consult a doctor?" "I was attended," answered the President "by Dr. John Smith, Dr. Howard Jones, Dr. Samuel Anderson, Dr. Raymond Brown, Dr. Roscoe Nelson, Dr. Isaac Nelson, Dr." -- and after the President had named at least 15 doctors, they appeared to try to cut him off tactfully, but he went on naming more and more doctors, while apparently they tip-toed out. Next, the reporters were interviewing Lady Bird Johnson, while being shown through the White House.

"Oh," said a reporter, is this the door to the Oval Office?" "Yes," came Mrs. Johnson's voice unmistakably, "tip-toe, and just peek in through the door, but don't open it wide." Next we heard on the record President Johnson's voice still naming doctors who had attended him for a very slight cold.

They asked Governor Rockefeller: "Governor, just what are the principle duties of a Governor of New York?" "I haven't the slightest idea," came back the actual voice of Nelson Rockefeller. I won't bore you with more, but you would get a good laugh if you heard this comedy record. It shows how, with a little editing, tapes may be carefully clipped and put together so as to make a person, in his own voice, say the very opposite of his intention. For this reason a tape recording of a telephone conversation is, and ought to be, illegal.

To say that this tape had been made of an ultra-private telephone conversation in which I trusted the other party, was a real shock to

me, for this, connected with other happenings, caused me to lose total faith in and respect for a man I had esteemed highly and loved. God Himself showed me that this man was part of the conspiracy to destroy or take over God's Church, and several events, of which this is one, have since verified what I knew unmistakably God had put in my mind.

It is sad and regrettable that in this mortal life we do have to frequently learn that those we had loved and to whom we had entrusted major responsibilities were not worthy of that trust. God says "Trust no man."

FROM PASTORAL ADMINISTRATION

Greetings Fellow Ministers!

Mr. Meredith will be returning from San Antonio, Texas today (Monday) after completion of a three-night campaign there. Word from the team there indicates it was a fine beginning for our campaign series. Attendance ranged from about 288 to 432. New attendance was low from the beginning, however, ranging from 85 to 58, but the program went very well, and the brethren and new people were very appreciative.

Next weekend, May 11-13, I will be conducting a campaign in Denver, Colorado, so would certainly appreciate your prayers for its success. There are seven campaigns planned for the months of May through the first weekend in August. We will enclose the dates, places, and speakers at these campaigns in this Pastor's Report as a reminder so that you can ask the brethren to pray for God's blessing on each of them.

Last week I was in Seattle, Washington and Portland, Oregon for meetings with all of our ministers and wives in those areas. Mr. Norman Smith joined me in Portland and we had a very profitable time discussing the various problems and needs of the ministers and churches in those areas.

Certainly the northwest has to be one of the most stable areas church-wise in the U.S. The ministers up there are doing a very fine job and expressed their loyalty to God's Work and to his apostle, Mr. Herbert Armstrong. Mr. Smith is doing an excellent job as area coordinator and I want to thank him publicly for the way he is working with the minsiters and churches in his area.

Included in this Pastor's Report will be a list of the summer transfers including men going out from Sabbatical and those coming in. We have tried to take into consideration all the various factors and the personal needs and desires of the ministers and wives affected. But sometimes the need for a certain minister for a certain area overrides personal considerations and we <u>must</u> put God's Work and the needs in His Church first in our lives.

Mr. Meredith and all of us here on the Pastoral Administration team want to thank those of you being moved or transferred for your loyal, cooperative attitudes. I think most of you are happy with your assignments, but there may be a few cases of disappointment. I am sure God

will bless all of you and make up for any inconveniences you may suffer as a result of transfers if you maintain a right attitude and keep God and his Work first in your lives. In the ministry we are all servants and must be willing to go where we are needed, when we are needed.

Pentecost is coming up on Sunday, June 3, as all of you know. We will be sending some men out from Pasadena and will be notifying you when we consider the various requests coming in for speakers.

I would like to close by briefly explaining how one minister who recently had to be put out of the Church was able to deceive a large part of his congregation into following him. I have given this a lot of thought and would like to relate to you the following points:

He began emphasizing certain Bible doctrines and teachings with the implication that the Worldwide Church of God is not following the Bible. He began saying that Christians should follow no man and that no man has any spiritual authority over us—only Christ is over us, implying that Mr. Herbert Armstrong has no authority over us. He alleges that Mr. Herbert Armstrong is departing from God's way and becoming Laodicean, and imparted his feelings to the brethren.

He used the legal problems we are having in a totally <u>negative</u> way -- the charges against us, the lawsuits, the sit-ins, etc. to say that we are hiding something and that is why we are (supposedly) not being subject to the civil authorities according to Romans 13.

He has been in regular contact via phone with Garner Ted Armstrong for many months and also contacted the Church of God Seventh Day in Denver. This minister believes God is using them to do a great work also and convinced many of the brethren of this.

He is saying Mr. Herbert Armstrong learned most of the basic truth that he knows from the Church of God Seventh Day and not directly from God and the Bible as he claimed.

And finally, he convinced most of the brethren under his responsibility that no one can ever put them out of God's Church--that they are only leaving one era of the true church to join with another. He convinced most of the brethren that the Worldwide Church of God is becoming Laodicean and that they would be better off associating with the Church of God Seventh Day and/or Garner Ted Armstrong.

I gave a sermon recently at one of the Pasadena churches on how this happened and explained how this minister was able to accomplish this over a period of many months. He was very subtle but some of the loyal members began to detect his disloyalty and reported it to us here at Pasadena. This minister was actually accepting a paycheck signed by Herbert W. Armstrong but was, in essence, working undercover for Garner Ted Armstrong. I know he would deny this, but it is the truth.

I will be writing up answers to the above points for a later issue of the Pastor's Report. In the meantime give them some thought. These are issues you need to be aware of and be prepared to answer.

That's all for now. Thanks again for your loyalty, faithfulness and dedication.

INTERNATIONAL NEWS

United Kingdom

March 1979 produced the largest monthly mail income for the U.K. and Eire in almost 2 years, with first account mail income up 32% over March 1978. On March 31, there were 2,092 members in the U.K. and attendance now averages 2,430 in 37 churches. This latter figure was increased from 34 churches in January of this year when, as a result of the sale of the College, the Bricket Wood church 'expanded' to form four new congregations. St. Albans now serves as the headquarters church.

A major "first" for the Work in Britain this year is our venture into Ideal Home Exhibitions and Agricultural Shows. A special Plain Truth display, complete with a recorded audio-visual presentation, is being used to make the public more aware of the name and content of the magazine. The focus of the display is a full-colour brochure, giving details of who and what lies behind the magazine and offering a sixmonth trial subscription. (500,000 of these brochures are being printed in total). Around 25 exhibition sites will be visited before the end of October -- 7 in the month of April alone (Southampton, Edinburgh, Manchester, Nottingham, Bristol, Hull and London).

In most cities the exhibitions are being backed by the distribution of "Plain Truth offer" leaflets to households (10,000 or 20,000, depending on location).

Caribbean

In spite of the current crisis in the Church, incoming mail is up 21% over the first quarter of 1978, and our income was up 33% for the same period. We are anxiously watching these percentages because some Islands have increases of more than 100% while others are as low as 3%. What this means is that the income received is not always in the place where it is needed. Because of currency restrictions there is very little interchange of funds. Below is a breakdown of our six mail receiving offices, which will illustrate this point.

Barbados, up 8%; Bahamas, up 4%; Bermuda, up 68%; Jamaica, up 111%; Trinidad, up 46%; Guyana, up 100%; Puerto Rico, up 3%. The areas from which we can move funds more or less freely are Bermuda and Puerto Rico.

Latest statistics reveal the following data: PT circulation, 27,638; added year-to-date, 611. Good News, 1,097; CC active, 1,159; Baptisms (year-to-date) 18 which means overall membership has increased by 2-4% during 1st quarter of 1979.

Newsstand distribution is now accounting for as much as 30% of new subscribers in some areas. In Puerto Rico, we are distributing 3,500 copies of the Spanish Plain Truth every month. This is a healthy increase over the 800 copies per month we were distributing a year ago. The response is very high in Puerto Rico. About 8% of the cards are returned.

The first public Bible lecture (in Spanish) was conducted in Santo Domingo, Republica Dominicana, on March 25th. Thirty-three persons attended, and a second study is scheduled for May 12th. Nineteen additional persons in other parts of the country were also contacted

for the first time thorugh personal visits made by Stan Bass and Albert Sousa. It seems as though God may have opened a door in the Dominican Republic, and hopefully a church can be started there in the not-too-distant future.

Philippines

The month of March 1979 had 37.5% increase in income over March last year. This excellent increase brought our year to date increase to 21.70% -- up from February's year-to-date increase of 14.50%. A total of 7,144 letters were received in the office for March -- another fine figure.

There are now 16 churches or local congregations in the Philippines as of April 1. Santiago, Isabela, some 330 kilometers northeast of Manila was inaugurated March 31; the inauguration was attended by Messrs. Colin Adair, Pike Mirto and Pedro Ortiguero. Eighty-seven (87) were in attendance including visitors from Manila and neighboring Benguet Province.

While in the area, Mr. Adair spoke on moral values to almost 100 elementary-level school teachers. He also held a PLAIN TRUTH Lecture.

French

Mr. Apartian has just returned with exciting news from four weeks in Europe in which he conducted 9 public lectures. The one conducted in the Sheraton Hotel in Paris was attended by approximately 400 new people -- a majority being listeners to "Le Monde a Venir" radio program at 5:30 a.m.

The first Bible study conducted after the lecture by Mr. Sam Kneller, pastor of the Paris church, was attended by 51 new people.

Campaigns conducted in both Brussels and Liege in Belgium were attended by approximately 50 new people on each occasion. Mr. Apartian reports the churches are very strong and solidly behind Mr. Herbert Armstrong.

PUBLISHING SERVICES UPDATE

A short update on Quest magazine. Things are going much better than expected and we are much closer to breaking even than we had planned. This is mainly due to very careful control of our production costs, both here in Pasadena and in New York. The April issue was the first of our new style monthly format magazines. As you know, we were publishing every other month but Quest was so well received by the public and the big advertisers that we decided to go monthly and reduce the cost to \$1.75 per issue on the newsstand and \$12.00 per year for a mailed subscription. This may seem a strange way to cut costs but by going

monthly we reduced our overhead for each issue because our staff costs remain the same and because of now being monthly, we dramatically increased our advertising revenue; in fact we almost doubled it. This, coupled with a better reader response to the lower subscription price, is proving to be a winner.

The other evening a few of us represented Quest at an award ceremony in Los Angeles. The magazine was in the top five for best cover of 1978 selected from over 100 national magazines.

Some of you have asked for a complimentary subscription to Quest. The answer is yes. Each minister will now receive a complimentary copy. If you already have a subscription that you paid for, we suggest you pass your complimentary copy onto somebody in the community.

The total, worldwide circulation of the PT in all editions, including the newsstands was 2,303,214 for the March issue. This is slightly down from the total figure for January of this year: 2,383,719. While circulation figures are down in some parts of the world, they are up in others. Australia, Central and South America, the Philippines, Southern Africa, Southeast Asia, and a few other international areas all register significant increases in PT circulation. Circulation has slipped somewhat in the United States, the British Isles, Canada and Germany, however.

EMPLOYEES UPDATED ON RECENT EVENTS

Having returned recently from the Orient with Mr. Armstrong, on Thursday morning, May 3rd, Mr. Stanley Rader updated church and college employees about recent developments in the Work. Dozens of questions were also asked and answered. He did not want to preempt Mr. Armstrong who is writing to the brethren about the trip, but he did confirm that the entire trip was a complete success and gave just a few details.

As usual, Mr. Armstrong went in his private jet, he stayed in the best hotels, had a major banquet and gave the Prime Minister of Japan a piece of Steuben crystal. Plans call for another trip next month, this time to Tunisia and Morrocco. Then they will follow that up with a trip back into Egypt and Israel accompanied by Mr. Armstrong's "Japanese sons." After that, in the latter part of August Mr. Armstrong is to visit China -- Peking and perhaps several other cities -- then make a return visit to Japan, and finally go to the Philippines for a mini-campaign during a 3-to 4-day visit in Manila. "All this will drive the Attorney General right up the wall," mused Mr. Rader.

Mr. Rader also noted that newspapers did not play up Mr. Armstrong's recent trip to Japan. Had they drawn attention to the aspects of Mr. Armstrong's trips which the Attorney General has objected to, he thought

the stories would have ended up being too complimentary of Mr. Armstrong and the Church because they would have had to report exactly what Mr. Armstrong accomplished and who he met.

Stepping Up Our Projects In Japan

Mr. Rader told the employees that Mr. Armstrong affirmed all of our old programs and will be taking on new projects, stepping up our activities in Japan. When Mr. Armstrong returns to Japan en route to China he plans to have a public Bible study with Plain Truth subscribers. Further, we are going to step up distribution of the Plain Truth in Japan and reinstitute the newsstand program there. Looking down the road, it is hoped that this will bring forth a Japanese language work over the next decade.

Commenting about the extraordinary favor God has granted the Work in Japan, Mr. Rader said that "these people have a great veneration for Mr. Armstrong as an individual and as a unique human being. They have a great feeling about his spirituality and look upon him as someone of great help to them. They like to /also/ be of help to us."

He noted that Mr. Armstrong's "Japanese sons" have been great friends and that there is much they can do for the Work. They give a lift in some places and they have helped knock down barriers in others that would otherwise be there. "They have, as Mr. Armstrong would say, opened some doors for us. Maybe doors that would open up anyway, but they do give us an assist."

"Doors" On Western Shores, Too

Answering inquiries about the European Work, Mr. Rader said that we have a strong branch office operation in Europe. He said that we are going to do our best to "beef up those operations over the next few years." Last fall Mr. Ray Wright had done a complete study of ways to develop the Work in Europe. We were ready to implement much of that this winter and spring, but we had to put that on the back burner because of the crisis.

"As far as the leaders are concerned, there is no great effort that we'll have to make to meet them," remarked Mr. Rader. "We could do so at any time. But they are the developed countries and I think that we have to be prepared in those countries in order to do more than just meet the leaders. We are going to have to be able to spend money in those countries as we do here, in order to compete with all the other things that are trying to attract the public's attention with goods and services."

Mr. Rader observed that our offices in those countries have only so much indigenous income and that we can only give them so much support, whereas it will take more money from the United States to get that particular effort moving in some vertical curve. He said that since the recent events have come about states side, the European Work will require a fresh look so as to determine what we will be able to do on a country-to-country basis. Meanwhile, he said "we are holding our own and, more than that, we have good dedicated people" in the European Work.

Much Potential In "The Incredible Human Potential"

Mr. Armstrong's book, The Incredible Human Potential, is behind schedule about 6 to 8 weeks in reaching the bookstores, but there is another way

in which it will also be furthering the Great Commission. The book will be mailed to the heads of state, ministers of government and ambassadors we have dealt with in the past or are dealing with at the present moment. "They will go out as a matter of course just as we send them other materials: Quest magazine, The PLAIN TRUTH, and so on. So that book will reach those people in that way." Mr. Rader added, "We are not going to send it to people we do not know. Mr. Armstrong does not like to foist anything upon someone or force it on them."

The Sun Also Rises On Our Finances

"Income is up /approximately 10-11% over this time last year and our department managers have managed to ease the working capital strain by monitoring the outflow of cash," reported Mr. Rader. He was also glad to report that the banks are all indicating a willingness to again extend credit to us. He said Mr. Jack Bicket, who is Assistant Treasurer, is in the process of determining which banks will give us the best terms, best interest rates and the best service.

Mr. Rader explained that the banks are now more aware, as is the <u>informed</u> public, that this lawsuit is much different than it was in January. Instead of being in a state of seige we are merely tending the technical aspects that have yet to be resolved. The lawsuit still needs to be concluded one way or another: either dismissed, thrown out or won. The immediate threat to the institution is now a thing of the past, but we still have to normalize our business relations.

State of the Lawsuit

So where are we in the legal process? Mr. Rader explained that we are not yet appealing to the California Supreme Court. We have appealed to the District Court of Appeals — that is the first step in the appellate process. That takes time to prepare. The record has to be collected and certified before sending up to the appellate court. We file a brief (a concise statement of the main points of the case), then the opposition files a brief stating the state's position. Then the matter is studied by the court. There will be an oral argument where our lawyers and the Attorney General appear before the court. Then more time is taken for more study and review by the court and then a decision will be handed down.

In the meantime, the District Court of Appeals has granted a 30-day "stay" on other aspects of the case (the questioning of the surety pledges and the receivership accounting) pending our filing a "writ of certiorari" (an order of a higher court to call up the records of a lower court) with the Supreme Court of the United States. That will be filed this week. The Church is asking the Supreme Court to extend the "stay" of the California court pending the determination of whether or not they will review our case. The U.S. Supreme Court is not required to take this matter up now; it is merely at their discretion to do so. The chances are very slim that they will treat our writ as we want them to, but there is always a possibility they will, especially because of the important first amendment issue presented in our petition.

Meanwhile, the Church is not being directly hampered by the state or by the orders of Judge Title in carrying out its commission. They have both been frustrated and thwarted in their efforts by our having taken our rightful legal recourse.

Audit Nears Final Stages

"The audit is coming along fine," announced Mr. Rader, who had just spoken to representatives of Arthur Andersen and Co. The auditing firm is putting the finishing touches on the audit the Church commissioned in March. It is expected to be ready by the end of the month or early part of June. "I think the report will be such that it will be very difficult for the Attorney General to maintain himself in this lawsuit or to justify his conduct once the report is reviewed," Mr. Rader assured the audience.

Oops! A Refund?

As reported in a previous issue of The NEWS SUMMARY, the IRS is examining Mr. Rader's personal finances. One employee asked Mr. Rader about the rumor that he would be receiving a refund from the federal government.

Mr. Rader explained, "My tax accountants have indicated that for those years which are 'open years' (meaning years for which I may still file an amended return) there were very substantial deductions which they had advocated at the time that I take, but that I decided I would not. Now that we are involved in a tax audit for these years, they said they will file amended returns. They will therefore use the deductions they did not use before. It is their opinion that those deductions will produce a tax refund.

"The matter is proceeding in_the normal course of events. It is a process of elimination. They /the IRS/ obviously were given the same type of false information as was the Attorney General and they are duty-bound to chase these leads down. But I don't work for any other entities /other than God's Work/ nor do I receive benefits from them."

Troubles Could Have Been Avoided

During the meeting Mr. Rader stressed the importance of understanding how heinous were the actions of Mr. Cole and others who conspired with him. "If we had known for certain about the lawsuit we could have stopped it. That was the Benedict Arnold nature of Mr. Cole, Mr. Antion, Dr. Kuhn and others, some of whom are probably still working for us," Mr. Rader explained.

"Mr. Armstrong has said we are not going to go on a 'witch hunt.' We know who some of those people are, we know where their sympathies were. But Chapman, for example, admitted under close questioning he had been called by the attorney who represented the dissidents. He never told Mr. Armstrong, he never told me, he never told Mr. Helge. He then went down there and he signed an affadavit attacking Mr. Armstrong."

Mr. Rader continued to explain that "other people were involved. If we had known for certain even one day before, this lawsuit would never have occurred. The whole thing could have been prevented by one phone call! That's the nature of Mr. Cole's misconduct. Now he told Mr. Armstrong that a lawsuit was coming, but he didn't say where it was coming from, he didn't say he knew the people that were involved, he didn't give him /Mr. Armstrong/ the information necessary for us to act. When Mr. Armstrong asked me about it I said, 'I haven't even heard the rumor.'"

Mr. Rader mentioned that a few months before, Mr. Helge had lunch with Mr. Cole to talk about certain rumors in the field. Mr. Helge started to

explain that these rumors were false and what should be said. Mr. Cole then told Mr. Helge, "We don't want your help. We just want to tell you what the conditions are."

"The whole thing was very beautifully orchestrated," said Mr. Rader. "It just_didn't work. It caused some damage and it brought a lawsuit, but it /turned out/ much different than it was planned. But for the fact that the state is involved, the whole problem would be behind us. Now, as long as we've got the problem we want to maximize the coverage and the value of keeping the name of the Worldwide Church of God out in front so more people will want to know about it. I am certain that more and more people will be mindful of the need to know more about the Worldwide Church of God."

A few people have been critical of Mr. Rader's remark, "By God you've got it," made to Mike Wallace on the "60 Minutes" program. At the end of the employee meeting Mr. Rader recalled what led up to that point in the interview and what he had in mind at the time.

Mike Wallace had just asked, after hearing that Mr. Armstrong gives Steuben crystal gifts to heads of state just as President Eisenhower did, "Mr. Herbert Armstrong is a head of state?" Mr. Rader replied, "Exactly, exactly." With that Wallace queried, "Then you are his secretary of state?" and Rader quickly responded "You've got it. By God you've got it. That's it. That is the whole key. This is a state and we are representatives of God and I am Mr. Armstrong's secretary of state."

Mr. Rader continued to explain to the employees in the Auditorium, "When I am on these programs I am very mindful of what I say. I have to think of our audience and the general audience. I have to try to think to give a little levity to balance it off. Any who have seen 'My Fair Lady' will remember words of that nature when professor Higgins was delighted with his pupil, Elisa Doolittle, getting the point.

"In this case, however," continued Mr. Rader, "I quickly mixed it with two things. A touch of levity (if you saw the video tape again you'd see I smiled very broadly) and I was also indicating /that/ 'BY GOD' his mind had been opened up. "SECRET TAPING" OF THE 60 MINUTES INTERVIEW

As many of our readers will recall, Morley Safer held up a couple of tapes at the end of the "60 Minutes" Mailbag segment April 22, and said that Mr. Rader didn't know that they knew he was secretly taping Mike Wallace while Mike was taping him. The obvious intent was to make it appear that their use of surreptitiously obtained tapes was not wrong — that we did the same sort of thing.

We did tape the "60 Minutes" interview in Mr. Rader's office. Not with a mike under Wallace's chair, though. But, this was not a confidential telephone conversation. This was an interview being made expressly for

broadcast to the whole nation. Everyone in the room knew the interview was being taped. No confidentiality was being violated.

In contrast, the surreptitiously obtained tapes of Mr. Armstrong's <u>private</u>, <u>confidential</u> phone conversations were made <u>without his knowledge</u> while he thought he was speaking to an associate in confidence. The tapes were spliced together and edited to say what they wanted.

Evidently "60 Minutes" does not think their viewers are smart enough to see the difference between legally obtained tapes of interviews made for public release and illegally obtained tapes of private, confidential telephone conversations!

PASADENA DEACON ATTACKED BY FORMER CHURCH MEMBERS

Mr. Joe Kotora, a deacon in the Pasadena congregation, was attacked Wednesday evening, May 2, while serving a subpoena on one of two former Church members who started the original lawsuit against the Church. The Church is exercising its legal right to question parties of the opposition under penalty of perjury. This taking of depositions is part of the discovery phase of the lawsuit. The following is a press release distributed in the Southern California area which gives details of the incident.

Worldwide Church of God Press Release May 4, 1979

Mr. Joe Kotora, deacon in the Pasadena Church, was attacked Wednesday evening by David Morgan, a relator in the primary lawsuit against the Church. The attack came after Mr. Kotora and Kevin Dean served a subpoena for a deposition to Mrs. Earl Timmons. The subpoena was necessary, due to the failure of the relators to appear after being previously served.

The incident occurred in the officer's parking lot of the Altadena Sheriff's Office. Mr. Kotora and Mr. Dean had followed the party of three to the Sheriff's Station after being followed by the trio for nearly a mile. Upon stopping at the Sheriff's Station, Mrs. Timmons left the car and was approached by Mr. Kotora—who told her he had a subpoena for her and placed it on her arm. As Mr. Kotora walked away the subpoena fell to the ground, and Mrs. Timmons grabbed Mr. Kotora's \$30 sweater, ripping it, and screaming, "You get out of here!"

Mr. Morgan, outweighing Mr. Kotora by approximately 150 pounds, viciously bear hugged Mr. Kotora. He then proceeded to bash Mr. Kotora's head against the parked police car, while Mrs. Timmons continued to claw and hit Mr. Kotora. As an after thought, and realizing their plight, Mr. Morgan began screaming that the lady was being attacked.

Hearing screams, sheriff's deputies came from their offices to restore order. Mr. Kotora was found to have a gushing head wound, and was led into the station where that, and his other injuries,

were subsequently attended. After several minutes of cross-examination to both parties, the deputies allowed the subpoena to be served while they looked on. Mr. Kotora has not as yet chosen to file suit for assault and battery against the former church members.

Only time will tell whether Mrs. Timmons will obey the law and show up to answer questions about her part in the lawsuit against the Church. Others have shown a severe case of reluctance to answer questions, but have shown no reluctance whatsoever to throw around vicious lies and rumors. Armstrong the information necessary for us to act. When Mr. $\overline{\text{Armstrong}}$ asked me about it I said, 'I haven't even heard the rumor.'"

Mr. Rader mentioned that a few months before, Mr. Helge had lunch with Mr. Cole to talk about certain rumors in the field. Mr. Helge started to explain that these rumors were false and what should be said. Mr. Cole then told Mr. Helge, "We don't want your help. We just want to tell you what the conditions are."

"The whole thing was very beautifully orchestrated," said Mr. Rader. "It just_didn't work. It caused some damage and it brought a lawsuit, but it /turned out/ much different than it was planned. But for the fact that the state is involved, the whole problem would be behind us. Now, as long as we've got the problem we want to maximize the coverage and the value of keeping the name of the Worldwide Church of God out in front so more people will want to know about it. I am certain that more and more people will be mindful of the need to know more about the Worldwide Church of God."

About Mr. Rader's Statement "By God You've Got It!"

A few people have been critical of Mr. Rader's remark, "By God you've got it," made to Mike Wallace on the "60 Minutes" program. At the end of the employee meeting Mr. Rader recalled what led up to that point in the interview and what he had in mind at the time.

Mike Wallace had just asked, after hearing that Mr. Armstrong gives Steuben crystal gifts to heads of state just as President Eisenhower did, "Mr. Herbert Armstrong is a head of state?" Mr. Rader replied, "Exactly, exactly." With that Wallace queried, "Then you are his secretary of state?" and Rader quickly responded "You've got it. By God you've got it. That's it. That is the whole key. This is a state and we are representatives of God and I am Mr. Armstrong's secretary of state."

Mr. Rader continued to explain to the employees in the Auditorium, "When I am on these programs I am very mindful of what I say. I have to think of our audience and the general audience. I have to try to think to give a little levity to balance it off. Any who have seen 'My Fair Lady' will remember words of that nature when professor Higgins was delighted with his pupil, Elisa Doolittle, getting the point.

"In this case, however," continued Mr. Rader, "I quickly mixed it with two things. A touch of levity (if you saw the video tape again you'd see I smiled very broadly) and I was also indicating /that/ 'BY GOD' his mind had been opened up. It only took /Mike Wallace/ an hour and a half /into the interview/. Later in the program I pointed out it took me almost 20 years to understand where Mr. Armstrong was coming from, what this Work was all about."

"SECRET TAPING" OF THE 60 MINUTES INTERVIEW

As many of our readers will recall, Morley Safer held up a couple of tapes at the end of the "60 Minutes" Mailbag segment April 22, and said that Mr. Rader didn't know that they knew he was secretly taping Mike Wallace while Mike was taping him. The obvious intent was to make it appear that their use of surreptitiously obtained tapes was not wrong — that we did the same sort of thing.

We did tape the "60 Minutes" interview in Mr. Rader's office. Not with a mike under Wallace's chair, though. But, this was not a confidential telephone conversation. This was an interview being made expressly for broadcast to the whole nation. Everyone in the room knew the interview was being taped. No confidentiality was being violated.

In contrast, the surreptitiously obtained tapes of Mr. Armstrong's private, confidential phone conversations were made without his knowledge while he thought he was speaking to an associate in confidence. The tapes were spliced together and edited to say what they wanted.

Evidently "60 Minutes" does not think their viewers are smart enough to see the difference between legally obtained tapes of interviews made for public release and <u>illegally</u> obtained tapes of private, confidential telephone conversations!
