SATAN INTENSIFIES PERSECUTION

Evidences increase and multiply indicating God's great Work through His Church (Philadelphia era) may be FINISHED in a matter of months.

We may be right now at the time of Revelation 12:7-14. I want to write another article on another phase of this prophecy which will appear in the August number of either The PLAIN TRUTH or The GOOD NEWS.

Satan's master stroke against God's Church came with the massive assault of the California Attorney General's office on January 3, last year. Satan failed to knock out and destroy the Church with that civil lawsuit. He only drove us closer together, and closer to Christ. It actually helped in the process of putting the Church back on GOD's track.

So now Satan is trying something he has tried a number of times before—since he could not knock out the whole Church with one blow, he is now trying harder than ever to DIVIDE and SEPARATE US by a vicious attack of false accusations against Church leaders. Proverbs 16:27 speaks of those who would try to accuse and defame: "A worthless man digs up evil, while his words are as a scorching fire" (New American Standard Bible).

Actually, Satan tried this in the attempt to have the State political government take over running of the Church. Both Mr. Rader and I were falsely accused (but not in the lawsuit) of siphoning off (stealing) millions of dollars every year. We did not need to dignify those monstrous lies with even a denial.

But now Satan is coming at us in a more subtle and even more outrageous and scurrilous accusation, implying personal immorality and sins.

Neither shall we dignify these infamous accusations and rumors with a denial.

Adolph Hitler is reported to have said that if you tell a little lie it may not be believed, but if you tell an outrageously enormous and impossible lie it will be believed.

Brethren, I have no need for refutation or of the defense of character witnesses, or personal recommendations. Listen to what the Apostle Paul said. The same Satan tried to ruin Paul's credibility among the Church. Paul said: "Do we begin again to commend ourselves? or need we, as some others, epistles of commendation to you, or letters of commendation from you?"

He answered, "Ye are our epistle (recommendation) written in our hearts, known and read of all men" (II Cor. 3:1-2).

Directly, or indirectly, you are all MY children in the Lord. This Church is GOD'S Church. Jesus Christ is its living HEAD. He chose and has used me as His Apostle--as His human servant and instrument through whom HE, not just I, raised up all this Church. It was God the Father who called me, and later all of you. Jesus Christ founded and built God's Church. He raised up and built the present Philadelphia era of God's Church. But He used me as the human instrument in so doing.

WHERE DID YOU GET YOUR BELIEF--THE DOCTRINES WE ALL HOLD SO DEARLY? Every doctrine--every point of belief--you received directly or indirectly through me as Christ's Apostle!

Jesus Christ built this entire Work. But He caused me to work as hard and as diligently as if I had built it--only, if I had tried to do it WITHOUT Him, as others have tried to build THEIR OWN CHURCHES, it would have fallen flat long ago.

Have I ever sinned? Yes, just as you and every one who ever lived, except Jesus, has sinned. But I have stood before you even as the Apostle Paul did, a sinner who DEEPLY REPENTED and WAS FORGIVEN BY THE BLOOD OF CHRIST. I learned 53 years ago that we must LIVE the Christian life in a spirit and attitude of repentance. I have done that, and my precious Savior has FORGIVEN and cleansed me of all sin.

Jesus said, "by their FRUITS ye shall know them." I do not need to dignify false witnesses by a denial of their malicious accusations, nor does Mr. Rader. The FRUITS are all the answer I need.

Not only did Christ use me in raising up the present era of God's Church, He used me in building it. And, when others to whom I had delegated responsibilities not only greatly exceeded the authority delegated, but tried to LIBERALIZE God's Church and turn it gradually and subtly into Satan's Church, Christ used me these past two and a half years in TURNING GOD'S Church around and SETTING IT BACK ON THE TRACK. HE WOULD NEVER HAVE SO USED ONE GUILTY OF THE SINS SATAN NOW ACCUSES, USING EVEN FORMER MINISTERS DISFELLOWSHIPPED FOR DIVIDING AND LIBERALIZING GOD'S HOLY CHURCH!

Mr. Rader's FRUITS have been GOOD. His service has been mostly in finance and legal areas, but the value of his services to the Church could not be estimated in dollars. And he has been LOYAL.

Church Plans Campaign Against California Inquiry

LOS ANGELES, June 7 — The Worldwide Church of God, under investigation by the California Attorney General's office, has decided to plead its case to the public. "We will spend whatever it takes," said Stanley Rader, the principal adviser to the church's 87-year-bld founder, Herbert W. Armstrong.

In full-page advertisements appearing in California newspapers this week and scheduled for other papers around the country later this month, Mr. Armstrong,

For the last 18 months, the 100,000-member Worldwide Church of God has been resisting a state investigation into allegations that Mr. Armstrong and other church officials misused church funds. The church contends that the investiga-

Inquiry Called Unconstitutional

In January 1979, the California Attorney General started an investigation into the church's financial dealings under state laws that govern charitable trusts. The church maintains that the state has

no jurisdiction over its activities and has called the investigation an "unconstututional assault on American freedom.

The church had hoped for an early ruling by the Supreme Court. The Court's refusal to hear the case, however, sets no legal precedent and does not preclude it from taking the case at a later date.

The Worldwide Church of God, which has spent \$2.5 million in the last 18 months on legal fees, was in receivership for four months early last year and so far has refused to comply with demands to

WHO DECIDES EXPENSES?

The Church's principal work is proclaiming the Gospel of the Kingdom of God to all the world, and Mr. Herbert W. Armstrong, the apostle and leader, has for a number of years been traveling around the world speaking to national leaders and conducting campaigns and meetings. The attorney general refers to the expenses involved in our Gospel work as "travel expense," which he feels is excessive. But how a Church spends its own money should be none of his business! If he wants to govern a Church according to his opinions, perhaps he ought to start his own, not take over ours!

EDITORIAL SPELLS OUT THE REAL DANGER

Seldom do the members of the media look into our case and perceive the real nature of the lawsuit and its threat to religious freedom. But below is an editorial from the June 5th Orange County Register which very simply cuts through the mishmash of facts and allegations and spells out the wrongheaded position the State of California is taking.

An Unwarranted Intrusion Into Churches

Earlier this week the United States Supreme Court decided to permit the California attorney general to proceed with an investigation into the Worldwide Church of God. Whereas some of the practices of the church are indeed questionable, the questions should be asked by the members of the church and not by the government. The Supreme Court's decision further blurs the separation of church and state and, consequently, is a step away from freedom of religion.

The Worldwide Church of God was founded by Herbert W. Armstrong in 1934. Its membership has grown to more than 70,000 and has an annual income near \$70 million. The church has been wracked by internal upheavals for several years. In January of last year the state filed a lawsuit charging church officials with misuse of funds and demanding the right to see all of the church's financial records. Further, the state tried, and still is trying, to put the church in receivership.

What seems to have motivated the state's legal attack were charges that church officials syphoned church funds for personal use. Church money going for expensive gifts to world leaders and colossal expense accounts are often cited as examples of the alleged misuse of funds.

But who is to judge what is the proper use of church funds? The state's action is nothing less than a claim that it has the right to determine the propriety of the financial decisions of religious institutions. If a church permits its officers to take too much in salary or other benefits, this should be determined by the members of the church. No one is forced to donate to a church. In this case, there is ample evidence that many members of the Worldwide Church of God are aware of the seemingly excessive expense accounts and are undisturbed by them.

But the state claims that it has as much right as members to be concerned with certain financial decisions of the church. The state's lawsuit is based on the concept that churches are little different than charitable trusts and that government can examine a church's records just as it does the records of any charity.

The state's position, not surprisingly, has met the opposition of a wide variety of religious organizations. They rightfully perceive that, if successful, the state's case against the Worldwide Church of God will alter the relationship between church and state — an alteration which will further erode religious freedom in the United States.

There is ample reason for concern. The use of church funds is a volatile issue in many congregations; state involvement can do nothing but complicate and aggravate an already touchy situation. The government should keep its nose out of the collection plate and leave the financial affairs of the church to those who voluntarily contribute to religious institutions.

PROGRESS REPORT ON THE PETRIS BILL

As reported in a recent Pastor General's Report, there is a bill going through legislative channels in Sacramento which would, if enacted into law, restrain the California Attorney General from intruding into churches as he did in the Worldwide Church of God.

Wednesday, June 11, the bill was passed by the Assembly Judiciary Committee by a vote of 9-1! It has, you will recall, already passed through senate committees and the state Senate itself by a vote of 21 to 1 before

proceeding to this committee. We don't yet know when the bill will go before the state Assembly, but in the next week or so we may have more news about this very important bill which could well have a profound effect on the future of churches in California.

Among those testifying before the Judiciary Committee in behalf of the bill was constitutional law expert Lawrence Tribe. Representatives of the Roman Catholic Church and other major denominations testified personally before the committee and have been responsible for the entire effort to strip the Attorney General of his power to control Churches—a power he has clearly abused in our case and others.

NATIONALLY-KNOWN COMMENTATOR INTERVIEWS MR. RADER

Many Southland brethren were tuned in to their radios Thursday, June 12th, as George Putnam interviewed Mr. Rader on station KIEV in Glendale. Mr. Putnam opened with some very interesting remarks which focused on the previous Sunday's "60 Minutes" segment about the Church:

"I've noticed a very strange and sad tendency on the part of '60 Minutes.' Since it became one of those in the top 10, often topping the top 10 in the Neilsen race, it has resorted to some tactics of which I disapprove.

"I think journalism is evenhandedness and when you do a commentary, as I have done in the past ('One Reporter's Opinion') it should be set separate and apart from the body of the news. But in '60 Minutes' it lops over.

"There is a tendency in adversary journalism to take a subject that is, of course, of national interest and, particularly when it has gone to the courts—and to take that subject and to arrive at a conclusion, and then back off the conclusion you wish to make and then to fill in the bits and pieces as in a puzzle. And I think that is what happened [again].

"First, I noticed it on the Kissinger story, concerning the Shah of Iran in which I think a great injustice was done to the former Secretary of State, Henry Kissinger. Now I've never been a great booster of Henry Kissinger. We've had some confrontations, but fairness is fairness. And then last Sunday evening [June 8th] I was appalled to see the treatment of Stanley Rader and the Worldwide Church of God by Mike Wallace in '60 Minutes.'

"...That is not to say he [Mike Wallace] does not do the particular job he does very well. But I am questioning the lopsidedness of '60 Minutes.' And I say they could survive and do an excellent job and still be tops in the ratings, without taking that particular approach.

"Now, having said that, I must tell you I have no association with the Worldwide Church of God. And people have heard me expound on the subject of religion. I have had religion right up to here; I'm sorry. Maybe Stanley will save me by the time the day is over, but I've had about all the religion I can take.

"But I am going to tell you, as concerning the Worldwide Church of God, I think a great injustice has been done. Having said that we are going to get to our guest, and here he is in person: Mr. Stanley Rader."

The interview touched on many much publicized and frequently asked about topics. Mr. Rader fielded the questions with a spontaneity and candor that would naturally grab one's interest.

When asked about the members and how they are faring through all that has happened, Mr. Rader took the opportunity to praise God's people and describe the positive state of God's Church today:

"The members of the Worldwide Church of God are truly unique," said Mr. Rader. "They are a dedicated group, as you said. They are an educated group, a highly literate group. Very articulate. And they know why they are members of the Church. They know why this has happened because this was very clearly prophesied for them in the Bible...and pertains to the world now and in the future. So nothing surprises them about the persecution.

"But, as my ad mentions today [in the L.A. Times--see page 4 of this Report], if we did not have spiritual resources, as well as the leader-ship; financial resources, physical resources beyond the jurisdiction of the Attorney General of this state, we would have been destroyed. But because those spiritual and human resources as well as financial did exist and the Attorney General could do nothing to stop them, we are not only undestroyed, but the Church today is stronger than it has ever been before. More unified. There are more members, there are more baptisms, there are more members in attendance every week. And the Church in every way has grown and, in essence, prospered as a result of this persecution!"

Moving on, Mr. Putnam, speaking with unabashed feeling commented: "Now, the point I would make is this: It seems to me as I read the <u>facts</u>, not the fiction—not the allegations—but the facts in this situation, that I find a very serious <u>conflict</u> of <u>interest</u> here among judges, attorneys, receivers, etc!"

To this insightful comment, Mr. Rader remarked how so few reporters and journalists had seen the real story. "Naturally, when someone is accused of stealing \$45 million or \$70 million, that is an interesting story in itself," Mr. Rader acknowledged, and he said he didn't feel newspaper people should necessarily avoid that issue. But the really critical issue, in the final analysis, is the corrupt conduct of government officials in audacious disregard for constitutional law and the lessons of Watergate should have taught all Americans.

Unfortunately, time and space do not allow this Pastor General's Report to detail this interesting and informative interview. Many important points were addressed to the public (which constitutes one of the biggest population centers in the country). Touching on so many points about the Church, its beliefs and origin, about Mr. Armstrong and the Work as well as the lawsuit, is reassuring. In a great number of ways—some which we never dreamed of (lawsuits, national ad campaigns, interviews, etc.)—the existence of the Worldwide Church of God and its message is being brought to the attention of the nation in a powerful way before the climactic close of this age!

FROM MINISTERIAL SERVICES

Dating Between Members and Nonmembers

A number of ministers in the field have expressed concern about members dating nonmembers, and want to know what action they should take regarding such situations. Mr. Herbert Armstrong has specifically stated recently that such dating could lead to yoking oneself unequally (II Cor. 6:14), since dating naturally leads to marriage, and therefore should not be practiced by members.

Marriage was the first institution ordained of God in the Garden of Eden. From the beginning marriage was intended to be a <u>lifelong</u> relationship (Matt. 19:8). Human marriage symbolizes, through mutual love, sharing and fidelity, the relationship between Christ and His Church (Eph. 5:22-23). And Jesus Christ will not be "unequally yoked" to His bride. But more precisely, how does all this affect the considerations about dating and marriage with a nonmember?

God's people simply cannot isolate themselves from all social contacts with the world nor should they want to do so (remember Christ ate with sinners). Christ said His disciples were not to leave this world's society (John 17:14-15), but to simply not be of the world--its false ways, practices and religions. Paul asked "what communion hath light with darkness?" (II Cor. 6:14.) "Communion" or "fellowshipping" is certainly part of a dating experience. And an intimate and fruitful marriage naturally involves sharing and communicating deeply and frequently with one's mate. One's spiritual values, hopes and aspirations simply cannot find their expression as naturally and readily with a person whose interests cannot be truly linked together, for "the carnal mind is enmity against God..." (Romans 8:7).

Many people recognize the truism that when it comes to getting along with others, it is better to avoid "religion and politics." The principle behind the saying is that these subjects involve strong sentiments that usually set people apart. But spiritual unity between two people makes what may be a satisfactory marriage even better! And this unity strengthens God's collective spiritual Church.

Mr. Armstrong is fulfilling the prophecy of Malachi 3:1 as he prepares the way for Christ to return to His holy temple, the Church (II Cor. 6:16). In getting God's Church "back on the track" spiritually, Mr. Armstrong knows it is not in the best interests of the individual members, or the congregation as a whole, to ignore the lessons in God's Word concerning relationships with the unconverted which can lead to becoming unequally yoked in marriage.

After the exile, Ezra was led to institute reforms including the separating of the people from their foreign wives who worshipped false gods. Of course families where mates are not converted are not being divided today, but God's people are commanded to avoid becoming bound to the world (II Cor. 6:14.)

Remember, Solomon took to himself many wives and concubines. Perhaps Solomon found "strange women" more attractive even though God warned that it would turn his heart--yes, even the wisest man in history! Are any one

of today's brethren so wise or so attracted to those in the world that he or she can play with fire, and not heed the examples and commands of God's Word and the advice of God's Apostle today? What happened in Solomon's case? "And the Lord was angry with Solomon, because his heart was turned from the Lord God of Israel, which had appeared unto him twice..." (I Kings 11:8-10).

If there are members in your area who are dating outside the Church, they should be counseled. Then, if they are unresponsive to the admonition of God's ministry and the scriptures, such a one may have to be disfellowshipped. The deciding factor would be a wrong attitude—one in which the person demonstrates an unyielding spirit in defiance and opposition to God's Word—a spirit (or attitude) that has not been conquered by God. Such a one must choose between outside companionship and that of Christ and the Church, either or.

Update From Vancouver Office

May has been an exciting month in many ways. Two hundred and fifty miles south of Vancouver, Mount St. Helens began to erupt spewing dust and steam. Vancouver, E.C. had a hardly noticeable sprinkling of volcanic dust. But in the grain growing areas of Alberta, Saskatchewan and Manitoba, severe drought conditions and volcanic ash fallout threaten the harvest for 1980. This could have serious worldwide repercussions. During the holy day weekend, Mr. McCullough requested that the church pray for rain and two days later Mr. George Patrickson in Alberta was complaining of a flooded basement! The rains came but more is needed.

Despite the ominous trends of the month, mail income hit 30% for the first time in many years. Year-to-date income increase stands at 21.5%. The Pentecost holy day offering was 26% ahead of last year's.

The Work of the Data Processing Department was streamlined this past month with the installation of a mini-computer. Compatible and on-line with the Pasadena installation, it will facilitate easier management of information input and output and allow development of a more efficient business system.

On the media front, response to our various programs continues to be positive. Fifty new supermarket outlets for The PLAIN TRUTH newsstand magazine will be available in September in the Edmonton area. The T.V. Guide coupon for the three booklets, Dilemma of Drugs, Principles of Healthful Living and Managing Your Personal Finances, has produced over 7000 responses in the first week. Our goal of 10,000 responses certainly looks attainable. Final artwork for the newspaper flyer test campaign advertising the U.S. and Britain in Prophecy and The PLAIN TRUTH was approved this past week. The four-pager will be seen in five areas—Prince George, Red Deer, North Battleford, Peterborough and Moncton—where 170,000 flyers will be distributed. If the first campaign is successful, a major nationwide campaign will be launched in September/October.

UPDATE CONCERNING PROSPECTIVE AMBASSADOR COLLEGE STUDENTS

On behalf of Mr. Herbert W. Armstrong and the faculty, I wish to thank all of you ministers, worldwide, for your enthusiastic support of Ambassador College. Also, I wish to take this opportunity to thank you for your part in encouraging prospective students in your areas to apply for entrance into Ambassador College.

For many months now, it has been evident to me and to others of the administration and/or faculty of the College that God's ministry is now really "turned on" regarding the present course of Ambassador, whereas only a very few years ago, many of the ministers were somewhat negative about the College—due primarily to the problems which Ambassador was then experiencing. At that time some ministers expressed the view that they didn't prefer to have their sons and daughters attend the College—since they were convinced Ambassador had jumped the track in certain fundamental areas.

However, now that Christ has led Mr. Herbert W. Armstrong to put Ambassador back on the track, the vast majority of God's ministers worldwide are very favorable toward Ambassador College and are enthusiastically supportive of what God is doing in the College. Although I and the other administrators of A.C. diligently strive to carry out Mr. Armstrong's policies, we are not having the students march around in "uniforms and jackboots," as a former minister and administrator of the College had prophesied would happen.

However, let no one misunderstand: the present administration (under Mr. Herbert W. Armstrong's direct supervision and orders) is not winking at immorality, drunkenness, drug abuse, etc. in God's College. Under Mr. Armstrong's direct instructions, we may give an offending student one warning (and certainly will overlook a mistake--if truly repented of) should a student commit a serious infraction of College policy in one of these important areas of moral conduct.

How to Encourage Turned Down Prospective Students

On behalf of Mr. Herbert W. Armstrong and myself, and on behalf of the faculty, I wish to sincerely thank all of you ministers—and also the parents—for doing a very good job in encouraging prospective students in your areas to apply for entry into Ambassador. You have done such a good job that we had about three times as many prospective students wanting to enroll for College this fall as we were able to accept. This imposes a problem which I wish to discuss briefly with you ministers so you will have the facts at your disposal—should a prospective student ask you why he or she was not accepted at Ambassador for the coming college year 1980-81.

The Chancellor of the College, Mr. Herbert W. Armstrong, informed us some time ago that he does not want enrollment at Ambassador to exceed 500. I intend to see that his instructions are faithfully carried out.

But what can we do when we have about three times as many students wanting to enter Ambassador as we are able to accept--and still keep the total enrollment down to 500? Obviously, this poses a serious problem.

We have tried to solve this problem as fairly as possible by asking God to guide us in our selection of future students, and by diligently screening all applications.

Here, basically, is the way we go about selecting students for the College:

Firstly, we rely heavily on the local minister's evaluation--to get his input when possible. Over the years we have found ministerial evaluations of prospective students to be quite valuable.

Secondly, we consider such important matters as character, motivation, leadership, personality, and financial ability.

Thirdly, we have to use all the information at our disposal to determine, in an objective way, whether or not the applicant actually has the ability to do college-level work. And since many prospective students have not done all that well in high school, this can pose serious problems relative to their being accepted at Ambassador.

When we determine that a student <u>can</u> do college level work, if we are convinced he has good character, personality, leadership ability, and is highly motivated, then we will often accept such a prospective student—even if his college application indicates that he may not do exceptionally high level academic work.

On the other hand, if we have a prospective student who can make straight As, but appears to have weak character, little or no motivation, a dull personality, or mediocre leadership ability, we will not accept him/her into Ambassador.

In other words, we would prefer to accept a student who has <u>average</u> scholastic ability, but is highly motivated, has good character, personality or leadership ability than to accept a straight A student who is rather weak in the more important areas.

Prospective students who have already been accepted into Ambassador for the 1980-81 college year, which will begin in August, should not pose any problems for the ministry. And hopefully you will not have much, if any, difficulty handling those students who (for various reasons) were not accepted. I am sure you will encourage them every way you can.

Encouraging "Deferred" Students

Here are our suggestions as to how you might handle those students who have been "deferred" (who might have been accepted but will not be able to enter A.C. this fall because of very limited space).

We hope you will do all you can to encourage such prospective students-trying to keep them as positive and "turned on" toward the College as you can. Furthermore, you can inform them that they will be considered first next year--when we begin looking over the applications for admission to Ambassador for the 1981-82 college year!

You could also inform these "deferred" prospective students that they can use the coming year as a profitable time in which to develop their talents, skills, abilities, and also as a time in which they can earn—and save!—badly needed funds to help finance their education while at Ambassador.

Finally, there is one other problem area which merits mention. In some instances a "deferred" prospective student (or his friends, relatives, or even his minister) may compare himself with someone who has already been "accepted," and may ask: "Why wasn't I accepted? I am sure I'm just as qualified, or more so, as the one who has already been accepted by Ambassador."

I hope that everyone will be careful to <u>reserve judgment</u> in such matters-realizing that those who serve on the "Admissions Team" here at Pasadena are conscientious and impartial. We sincerely strive to be "fiercely impartial" in making such decisions, even when it concerns the children of ministers, faculty, or employees of the College or Church.

Again, thanks to all of you ministers for encouraging the young people in your Church areas to enter Ambassador College--and thanks also for your enthusiastic and loyal support of God's College!

ON THE WORLD SCENE

THE STARK REALITY OF EUROPE'S DEFENSELESSNESS BEGINS TO SINK HOME: The fissure between Western Europe (and Japan) and Washington is growing wider with each passing month.

Britain has defected from a united (albeit weakened) European stand on the Iran boycott issue. Only West Germany has held fast on President Carter's appeal for an Olympic Games boycott. Right after French Foreign Minister Francois-Poncet lectured U.S. Secretary of State Muskie on the virtues of

allied consultation, President Giscard d'Estaing popped up in Warsaw for a secretly planned confab with Soviet President Brezhnev. Soon West German Chancellor Helmut Schmidt will be off to Moscow, responding to a "peace offensive" from the Kremlin openly designed to further split the alliance.

Now, the signals are set for what could be the biggest storm yet to lash the Atlantic Alliance. The Common Market wants to bring the Palestine Liberation Organization (P.L.O.) directly into Mideast peace negotiations. Both the U.S. and Israeli governments are furious over this possibility. Even the Egyptians are not in favor of it.

Washington would have to veto any European-sponsored pro-P.L.O. resolution in the U.N. Security Council. Yet, France, Italy and Britain seem determined to push ahead--although they have yielded temporarily to pressure from the U.S. State Department to hold back on their own plan. "We did not believe the Camp David approach could work," says one French official. "We are convinced that a Middle East solution must be global." (Note Zechariah 12:2-3).

Europe's Weakness Exposed

There is loose talk everywhere in Europe these days about America's inconsistency and incompetence—and the eventual need for Europe to "go it alone." (Arthur Schlesinger Jr., former aid to President Kennedy, says that the United States is becoming the "Inspector Clouseau of nations"—likening America to the bumbling detective, played by Peter Sellers, in the "Pink Panther" films).

Yet, if Europe does indeed "go it alone," it has but two choices. The first is neutrality between the two superpowers. But in Europe's weakened state this would only amount to "Finlandized" submission to muscle-flexing Moscow. The second choice is to pay the price in an all-out effort to defend itself.

Neither alternative—when Europeans bother to think about such stark reality—is really palatable. Reports the news magazine <u>To The Point</u>: "In view of the distrust of America and the dread of Soviet attack that are spreading through the Western Alliance, the natural question is: Why don't the members of the alliance tighten their belts, arm to the teeth and prepare seriously for war?

"They could unquestionably afford it. The NATO countries' combined gross national product (GNP) is double that of the Warsaw Pact nations. Considering the very real Soviet threat, one would think the political leaders of the Western World ought to consider serious rearmament. Unfortunately, Western Europe, the United States and Japan are governed, not by statesmen, but by politicians who are primarily interested in getting themselves reelected."

Both Carter and Schmidt are locked in Autumn election battles; Giscard faces an election next Spring; and--just as we go to press--Japan's Prime Minister Masayoshi Ohira has just died of a heart attack. Japan is in political turmoil. National elections are only eleven days away and the ruling Liberal Democratic Party is virtually leaderless. Japan won't even have a prime minister to send to the free world economic summit in Venice on June 22-23.

But, getting back to Europe, the realization of just how weak, how exposed the continent really is, is just beginning to dawn on its men of influence Claude Imbert, chief editor of the French news magazine Le Point, writes in the June 2, 1980 Newsweek (European edition): "No matter how much we Europeans criticized American leadership in the past, we never ceased relying on it. So now that the United States appears to be failing in its mission as leader and champion of the European alliance, we are suddenly aware of our weaknesses vis-a-vis the Soviet Union--politically, economically and, most importantly, strategically. This awareness is heightened since most of us...worry that the United States may not resume its full world role for a decade--if not longer.

"In Europe, the prospects of a new relationship with the Soviet Union take several forms. They are all, however, underlined by the fear of a weak Europe compared to an increasingly strong, arrogant and self-assured Soviet Union, which now deliberately--and ostentatiously--displays its power. In recent talks with French diplomats, Soviet leaders didn't bother to conceal their new arrogance. Yes, they said, with positively Hitlerian brutality, we moved into Afghanistan. So what? It's no concern of yours what we do there.

"The Soviets use the same tactics over the question of nuclear weapons in Europe. Never mind about our SS20s, the Kremlin now says. They are not your concern. Just don't put Pershings [U.S. missiles] in Europe. There is no bargaining climate anymore, no more talk of equilibrium--simply a bald assertion of the bully's might. This behavior is the prelude to a bid for the neutralization of Europe, a long-term Soviet goal."

Too many Europeans, asserts Mr. Imbert, are succumbing to the "siren song" from Moscow. They are being lulled, he contends, by the idea that "Finlandization" may not be so bad after all. Mr. Imbert appeals to fellow Europeans to "take stock of ourselves before it's too late. We must remember that French President Charles de Gaulle only took an independent line because he knew that he was, in the last resort, secure within the overall U.S. defense orbit."

In view of America's decline and Russia's burgeoning power, Europe, concluded Mr. Imbert, "is only now becoming conscious of how alone it is. A stretch of solitude is always beneficial if it is used to reflect on ultimate goals and aims--especially if they involve an ultimate spiritual survival."
