

AMBASSADOR COLLEGE BEGINS WITH A "BANG!"

The 1981-82 college year, both at Pasadena and Big Sandy, has gotten off to a good start--with a real "Bang!" Even though we had a very good freshmen class a year ago, all of the members of the Pasadena faculty I have talked to think this year's freshmen class is the best we have had in many years.

At Pasadena during the faculty-freshmen reception, we were pleasantly surprised to see how friendly and outgoing the new freshmen students were this year. Also, I didn't notice a single male student who had an unsightly mop of hair. It is clear to us faculty members that you ministers "in the field" are instructing the young people in the churches in such a way that they now have a better picture of what is expected of them when they enroll in Ambassador. Keep up the good work!

Mr. Herbert W. Armstrong spoke to the students and faculty at the Orientation Forum, and then again at the regular Tuesday Forum just yesterday. He explained how it was that he instituted the weekly Forums at Ambassador in the first place. He said that during the first year of Ambassador, he let the carnal faculty members work out the details of the class listings in the College Catalog. They demoted the theology class to a two-hour (two-unit) minor, instead of having it listed as a three-hour major. Mr. Armstrong said Satan was trying to destroy God's College right from the very beginning.

But Mr. Armstrong thought of a way to correct this two-hour minor in theology deficiency. He simply instituted a weekly forum at which all students AND FACULTY were required to attend. This gave him another hour each week to speak to the students, and this also made it possible for him to give a little of the right kind of mind conditioning to those faculty members who did not want to see the Bible classes become the real <u>foundation</u> of Ambassador College. Mr. Armstrong said that he spoke straight from the shoulder at those forums, and some of the faculty members did a bit of squirming. The truth often hurts those who oppose it.

We sincerely hope Mr. Armstrong will be able to take all of the weekly Forums when he is in Pasadena. This will help to strengthen both students and faculty.

Also, I might mention that Mr. Armstrong taught the Principles of Living class yesterday. You early students of Ambassador may recall that it was Mr. Armstrong who first instituted this class in Ambassador as a means of communicating to the students vital information concerning proper attitudes toward sex, dating, marriage and family relationships. We hope he will have the time to take many of these classes. This will give the students an insight into his many experiences, thereby enabling them to receive firsthand accounts of his nearly ninety years of rich experiences in life and in the field of education. As previously reported, we sent 75 of last year's freshmen students (now sophomores) to Big Sandy in order to provide some continuity to the student body there, and as examples to the approximately 120 new students accepted at Big Sandy. Most of those sophomores will return to Pasadena next fall to continue here as third-year students, unless, of course, Mr. Armstrong decides to make Big Sandy a four-year college. (Mr. Armstrong has mentioned this as a possibility.)

Here are a few vital statistics concerning the makeup of the student body at Pasadena: There are 71 seniors, 128 juniors, 93 sophomores, 206 freshmen and three full-time diploma students. 128 are international students from 18 countries outside of the United States. This includes 55 from Canada, 23 from Australia, and 17 from England.

It looks as though the 1981-82 college year will be one of our best ever--if not our very best year. We know that you ministers have already helped to make it so by really working with the young people in your areas so that they get a good fund of knowledge and a solid spiritual foundation even before entering Ambassador College.

Thanks once again, to all of you ministers, for your part in helping to make Ambassador College once again truly God's College. We on the faculty are happy to have the wonderful opportunity of working with these very fine students.





#### Threats From Disfellowshipped Member

#### International News

<u>News From French-speaking Areas</u> Wednesday, August fifth, on their return trip from Paris where they received Mr. Armstrong on his European trip, Mr. and Mrs. Apartian flew to Montreal where they were very warmly received. The following Friday Mr. Apartian conducted a conference for all francophone ministers, deacons and wives. Discussions were held on doctrinal subjects as well as preparations for the Feast of Tabernacles. On the Sabbath there were 531 people present to hear Mr. Apartian speak.

To date this year in the French Work worldwide there have been 57 baptisms, 7,335 are enrolled in the Bible Correspondence Course, 338 donors have been added making a total of 1,028, and 67 new co-workers have also been added giving us a total of 2,128 for the French-speaking area of God's Work.

In Guadeloupe, Mr. Dubois, pastor of the two churches, informs us that he received 392 letters for the first six months of this year in comparison to 325 for all of 1980. This is an average increase of 240%. This increase is mainly due to God opening the door for the French broadcast on Radio Caraibes Guadeloupe. Because of the poverty and illiteracy, every letter represents many more people who are also listening to the broadcast.

In France, 2,000 new subscribers have been added to La PURE VERITE since July 1980 as a result of the card-holder displays at three different exhibitions in Paris and Toulouse. These new additions to our files are part of the 11,400 we have added since that date (excluding Canada).

The French language radio broadcast is once again aired over Radio Luxembourg every Tuesday and Thursday from 5:00 to 5:15 a.m. The shortwave program will continue until the end of the year.

#### Four Major TV Stations Produce Almost Half of Phone Response to Telecast

#### ON THE WORLD SCENE

FIGHTING ESCALATES IN SOUTHERN AFRICA--HERE'S WHY South African military forces are retreating from a week-long search-and-destroy mission--code named Operation Protea--deep into southern Angola from South West Africa, or Namibia. Their overall goal: to deliver a telling blow to bases and training camps inside Angola belonging to SWAPO, the Moscow-backed terrorist band whose goal is to take over power of Namibia by force. It is now obvious that Pretoria had two equally important objectives in mind when it launched its four-pronged armored attack: (1) to search out Sovietsupplied radar and surface-to-air (SAM) missile bases which threatened South Africa's Air Force, and, (2) to catch Soviet and other East block "advisers" in the act. Not much is known about the first objective yet, but it is believed that the air defenses were wiped out in a 90-mile-wide east to west swath north of the border. Regarding the second objective, latest reports are that at least four Soviet miliary advisers and military personnel were killed and one, a sergeant major, was captured.

The South Africans had been warning the West for years that Soviets, East Germans, Cubans and others were in Angola not just to prop up that country's pro-Marxist regime, but to give military assistance and training to SWAPO units. At Xangongo, 60 miles north of the Namibian border, journalists flown in by Pretoria authorities were shown evidence of direct Soviet involvement: a house from which, shortly before the attack, 27 Russians had hastily fled, leaving behind a mess of empty wine, beer and vodka bottles. Viewers of South African television were treated to pictures of burning Soviet tanks and tales of Soviet advisers fleeing for their lives.

Captured booty included massive quantities of weapons and propaganda. A complete 70-vehicle, Soviet-made SWAPO supply convoy was taken intact--part of a cache of 100 vehicles and fifteen tanks plus 200 tons of small arms and ammunitions. And an enormous amount of Russian propaganda material was found in SWAPO headquarters camp.

South African Defense Minister Magnus Malan, reported to be personally in charge of "Operation Protea," said that the mission provided "undeniable evidence indicating Soviet Russia's involvement in the terrorist onslaught against South West Africa."

The United Nations General Assembly, to be expected, condemned the South African "attack in Angola"--not SWAPO's 15-year long campaign of political intimidation, brutal assassinations of chiefs and village headmen in Ovamboland and the abducting across the border of thousands of Ovambo youths for forced indoctrination and military training. All of this is just dandy with the UN General Assembly--a body which even the liberal WASHINGTON POST once described as "an institutional outrage" and "a moral swamp." (The General Assembly cheered when SWAPO chief San Nujoma pledged to them in 1973 that he would intensify the "armed liberation struggle.")

The UN recognizes SWAPO as being the "sole and authentic representative" of the Namibian people. Three UN bodies channel aid directly to SWAPO. Since the U.S. supplies 25% of the UN's constantly expanding budget, many American tax dollars flow into SWAPO coffers.

Experts are convinced that it is the Reagan Administration's supposed "tilt" toward South Africa (which Reagan officials instead termed "even-handedness") that emboldened Pretoria to launch the raid, their most extensive cross-border missions to date. Mr. Reagan and his top aides have made a big issue of challenging what they call Moscow's primary role in the global terrorist network. That is why the South Africans were determined to catch the Russians on the scene.

The Reagan Administration cast the lone veto in a UN Security Council resolution condemning the South African raid (Britain abstained). The reason for the veto, said a State Department spokesman, was that it "didn't take into account the wider context of the problem"--e.g. the Russians.

However, three other members of the so-called "Western Contact Group"--West Germany, France and Canada--who along with the U.S. and Britain are supposed to engineer a Namibian independence plan, approved the resolution. Thus, on yet another key issue, the U.S. is being isolated from its key allies. The transatlantic rift is widening. This schism occurs at the same time that France, along with Mexico, has decided to all but recognize the leftist insurgent movement in El Salvador.

The upshot of the worsening situation in Southern Africa is that Pretoria has no desire to see a Communist flag flying in Windhoek, SWA/Namibia's capital. A one-party Marxist government right on its borders would have incalculable consequences for South Africa itself.

An editorial in the WALL STREET JOURNAL on September 2, 1981, tried to put the assault into Angola into perspective:

Before the world press picks up the Soviet line, it might be good to get a few things straight. First, the fight in Angola had nothing to do with race. The South African raiders consisted of both blacks and whites and so did the forces that resisted them. The raiders were countering a Soviet power play, the deployment of surface-to-air (SAM) missiles in southern Angola, escalating the continuing Soviet effort to take effective control of South West Africa (Namibia).

The U.S. Administration was quite right in refusing to condemn South Africa without equal condemnation of the Soviets. The fact that the U.S. stood alone in the Security Council, while France and Germany caved in and Britain abstained, is a mark of honor, not guilt. It was about time a U.S. administration stood up on the issue of Namibia. Most Americans have little understanding of the situation and thus become easy prey for those left-wing racism charges.

First of all, South Africa has made genuine efforts to prepare Namibia for independence as it is obligated to do under terms of the old international mandate that gave it control of the place. A constitutional conference consisting of representatives of the territory's ll distinct population groups...was convened in 1975. A national assembly representing all these groups was elected in 1978 by popular vote....The council has been taking over the tasks of government under the supervision of a South African administrator general. Many discriminatory laws have been repealed and a multiracial civil service formed.

The UN, however, has not recognized this government, insisting instead on turning Namibia over to the South West Africa People's Organization (SWAPO)....South Africa has resisted this out of a fully justified fear that a SWAPO takeover would mean Russians and Russian-backed terrorists on its border. The Russians would inherit Namibia's mineral riches and its position closer to the vital Cape sea routes. The world would then view a perpetual state of war, with thousands more Africans slaughtered or made homeless like the victims of Soviet conquest in Ethiopia.
