PUBLISHING SERVICES UPDATE

Caution Regarding Supermarket Distribution of PT

As you already know, PLAIN TRUTH newsstand distribution will begin through the Good Neighbor Bulletin Board program in 541 supermarkets in the New York metropolitan area, beginning with the June issue.

At this time our contract does <u>not</u> include areas outside this region. Therefore, magazines should <u>not</u> be placed on Good Neighbor Bulletin Boards in supermarkets located in <u>any other area</u>.

As the opportunity arises to increase the number of supermarkets involved in this program, we will inform pastors where and when distribution is to begin. Until that time, <u>distribution on the Good Neighbor Bulletin Boards</u> <u>outside the New York metropolitan area is prohibited</u>. We would appreciate it if you would inform all the brethren involved in the Newsstand Program of this policy.

I saw the Easter program as I was starting to leave for Easter services. I got my Bible out and wrote down the scriptures. I decided, while the program was still on, that I'm not going to keep Easter anymore and I'm going to quit my church. I really believe Mr. Armstrong's message.

ON THE WORLD SCENE

THE GREENING OF THE BUNDESTAG; STRAUSS MAKES HIS MARK; THE KREMLIN AND THE POPE

Petra Kelly, West Germany's most visible "Green," walked to the first session of the new Bundestag carrying a bouquet. Another Green Party representative wore green-and-black striped pants. Shunning the Mercedes limousines or luxury buses that transported CDU/CSU, FSP and SPD delegates to the parliament building, the 17 Green deputies marched from downtown Bonn rolling a huge globe representing "Mother Earth" and carrying dead fir-tree branches labelled "victims of acid rain."

However impressive the splash they think they made, the blue-jeaned Greens quickly found out how important they were in the parliamentary scheme of things. The April 11 NEWSWEEK put it this way:

The newcomers...soon discovered the limits of flower power.... Bundestag conservatives saw to it that the vehemently antinuclear Greens were barred from parliamentary committees dealing with national security. Bundestag leaders also maneuvered the Greens out of any of the chamber's four vice speaker positions, thus preventing a Green from ever wielding the gavel during Bundestag debates.

They savored at least one victory. Learning that they were to be seated on the extreme left of the Bundestag, the Greens insisted that they be placed [near the center] between the Social Democrats (SPD) and the CDU. That way, the Greens knew, they would be in full view of television cameras--and within better heckling range of the podium....

The Greens also vowed that they would continue their all-out opposition to any further "nuclearization" of West Germany--either in arms or in energy. That pledge is sure to plunge the Bundestag into sharp conflict before long.

Strauss Forces Policy Changes

Perhaps of far more significance than the parliamentary debut of the Greens is the growing political leverage exerted--behind the scenes--by Franz Josef Strauss. The Bavarian strong man is pulling the ruling coalition further to the right and into a more realistic posture with regards to the Soviet Union and toward communist inroads in areas around the world vital to Western interests. The same issue (April 11) of NEWSWEEK ran an article entitled, "Does Strauss Have Veto Power?" which said, in part:

Chancellor Helmut Kohl announced his cabinet lineup last week, and, as expected, Franz Josef Strauss didn't make the team. But the apparent snub hardly seemed to disappoint the beefy leader of the Bavarian Christian Social Union. Strauss had lobbied to become foreign minister as a payoff for delivering crucial votes in Kohl's election victory a month ago. In a series of wellpublicized leaks and splashy interviews, Strauss boasted that he had actually received an even sweeter reward. The chancellor, he claimed, had granted him a major behind-the-scenes role in the coalition, including a virtual right of veto over any foreignpolicy decisions.

The arrangement is certain to mean a <u>sharp swing to the right in</u> <u>West Germany's foreign policy</u>. Strauss recently laid out his views in a 27-page paper submitted to Kohl.... Strauss called specifically for a tougher line against the East bloc, and advocated closer ties with Peking as a means of nettling the Kremlin. He also favored a <u>firmer anticommunist line in Latin America and</u> Africa.

There were indications last week that his influence was already being felt. Strauss aides claimed that Bonn would soon drop its longstanding support for leftist [i.e. SWAPO] guerrillas fighting in Namibia and normalize relations with the South African-backed government by <u>reopening a consulate in the capital city of</u> <u>Windhoek</u>. More such initiatives are likely to follow. In the meantime, Strauss was clearly savoring his new role. Returning to his home base in Munich, he was gleefully telling friends, "I <u>don't care which chancellor serves under me."</u>

Strauss is alleged to have made that last statement several times in the past. Shortly before Chancellor Kohl decided on who was to be in and out of his cabinet, the March 18 TIMES of London editorialized about Herr Strauss's influence, whether exerted in Bonn or in Munich:

Above all the world can expect a shift to the right in the tone, at least, of West German foreign policy. Herr Strauss has a passionate interest in foreign affairs.... Changes are in the air, for instance a lessening of sympathy for SWAPO in Namibia where West Germany is a member of the five-country contact group trying to bring about independence. This would reflect Herr Strauss's view of Africa in terms of an East-West struggle and South Africa as a bulwark against Soviet influence on the continent.

There are already indications of a tougher stance towards East Germany and Herr Strauss will doubtless push for a harsher tone towards all the communist world, although he is too much of a realist to seek to undo the achievements of a decade of Ostpolitik. Such developments would doubtless be welcome in Washington and improve relations with the Reagan Administration.

Herr Strauss has to decide whether to accept Herr Kohl's offer of a post in Bonn or remain Prime Minister of Bavaria. His outstanding talents would be an asset to the government, <u>his independent mind and explosive</u> temperament would create problems, although it is debatable whether he would make life more difficult for the Chancellor from inside the Cabinet or hurling periodic thunderbolts from Munich. Psychologically, Herr Kohl has acquired a huge advantage over Herr Strauss by winning the election so well four years after the latter failed so badly. But the advantage is only relative, given <u>Herr Strauss's outsize</u>, <u>irrepressible personality</u>, his command over a sizable chunk of the coalition and <u>his unswerving conviction that he knows best</u>.

Plot Against the Pope Thickens

Authorities in France have information that supports testimony given to Italian authorities by a Turkish assassin, Mehmet Ali Agca, that when he tried to kill Pope John Paul II on May 13, 1981, he was acting at the behest of Bulgarian intelligence agents.

The evidence, though not conclusive, includes information from a Bulgarian official who defected in France in July 1981. If true, it <u>reveals how incredibly paranoic the Soviets have been about the impact of John Paul II upon their satellite empire</u>--even to the point of believing that he was an agent of the U.S. government--Zbigniew Brzezinski, in particular--in an attempt to subvert Poland. Reports the NEW YORK TIMES of March 23, 1983:

The official, Ordan Mantarov, 48 years old, told French intelligence agents that the plot to kill the Pope was devised by the K.G.B., the Soviet intelligence agency, and by the Bulgarian secret service, which many Western intelligence specialists consider subservient to Moscow. The plan was drawn up, Mr. Mantarov said, because the two agencies believed that the Pope was the keystone of a United States effort to subvert the Polish Government and move it away from the Communist bloc....

Mr. Mantarov, the Bulgarian who defected in France,...[said that Dimiter Savov, a top Bulgarian counterintelligence official] told him that in 1979 the K.G.B. concluded that the election of Karol Wojtyla as Pope the year before was <u>engineered</u> by <u>Zbigniew</u> <u>Brzezinski</u>, President Carter's national security adviser, who was born in Poland.... The response to the election of Pope John Paul II--made by the Soviet authorities and conveyed to the Bulgarians, according to Mr. Mantarov's account--was to "eliminate" <u>the Pope</u>, and the assignment was given to the Bulgarian security agency....

According to the French sources, Mr. Mantarov said...that when unrest mounted in Poland and the Pope supported the aspirations of Polish workers to organize into independent unions, Eastern European intelligence agencies became concerned that their fears were correct and the K.G.B. began discussions with the Bulgarian intelligence service on a way to eliminate John Paul II.

But why the apparent Soviet phobia with John Paul II? Simply put, the Pope's growing influence in the East--much of it unreported in the general press--extends far beyond Poland and even Eastern Europe, <u>right into the</u> <u>Soviet Union itself</u>. Here are excerpts from the article "The Battle Between the Kremlin and the Pope" which appeared in the March 30, 1983 WALL STREET JOURNAL. The author is Alex Alexiev, a Soviet/East European affairs analyst with the Rand Corporation. The growing implications of Soviet involvement in the attempt to kill the pope should lead us to question what might have motivated such a "crime of the century."...

From the day of the election of Karol Wojtyla as Pope John Paul II it was clear to Moscow that it had to deal with a formidable opponent... This was most dramatically demonstrated during his triumphant visit to Poland in June of 1979, which Moscow now believes gave rise to Solidarity. Speaking before collective Polish audiences numbering some six million, the pope...asserted that "no country should ever develop at the cost of another, at the cost of enslavement...conquest, outrage, exploitation and death." The pontiff's remarks in front of millions of people represented an unprecedented challenge to the legitimacy of the communist system and Soviet interests in Eastern Europe.

While the pope's influence on the events in Poland following his visit and until the imposition of martial law is fairly well documented, his revitalizing effect on the church in other Eastern European countries is less well known. In <u>Czechoslova-kia</u>, for example, the Catholic Church is experiencing a remark-able revival which has included widespread underground religious life with tens of thousands of participants and a clandestine press.

In <u>Lithuania</u>, a homogeneously Catholic nation with a long record of historical and cultural ties with Poland, the election of Wojtyla was greeted with elation. The church there has been experiencing a dramatic revival since the early 1970's, and has emerged as the most militant church in the Soviet Union... Open defiance of the regime through unauthorized religious processions, demonstrations and mass petitions of all kinds has become commonplace. The pope has firmly, if quietly, supported the Lithuanians' struggle. He has, for example, refused to appoint regime-approved church officials, considered collaborators by most believers.

No less troublesome for the Kremlin has been John Paul II's perceived impact on the Ukrainian Catholic Church of the Eastern Rite. The Uniate Church, as it is also known, has for centuries commanded the allegiance of the people in the Western Ukraine, which was incorporated into the Soviet Union following the Nazi-Soviet pact in 1939. As a result, it became an obvious target of the Soviet drive to extirpate Ukrainian nationalism and was the only church in the Soviet Union to be outlawed outright. Ever since that time, the Ukrainian Catholics have been persecuted and victimized like no other religious community in the Soviet Union.... In the spring of 1980, the pontiff convoked the first synod of Uniate bishops, which openly called for the restoration of the church.... Despite particularly brutal KGB suppression, an underground church with as many as 500 priests and 3 bishops is reported to be flourishing in the Ukraine. In February 1983 John Paul II convened another synod of the Uniate bishops and urged them to intensify their efforts in connection with the thousandth anniversary of Christianity in the Ukraine in 1988.

While the pope's influence has undoubtedly been strongest among the Catholics in the Soviet bloc it has had much broader ramifications. By emphasizing Europe's common Christian roots, he has consistently stressed its spiritual unity--East and West--and has gone beyond that to argue for the opening not only of borders, but also of (political) "systems." In a highly significant gesture, the pope has declared the Sts. Cyril and Methodius, who were instrumental in the spread of Christianity among the ancestors of many present-day Catholic and Orthodox Slavs, copatron saints of Europe along with St. Benedict, thus symbolically overcoming the centuries-old East-West division of Europe. It should come as no surprise then that the Kremlin's attitudes toward the pope some four years after his election and close to two years after the attempt on his life continue to be unremittingly hostile and increasingly confrontational. For Moscow, John Paul II was and continues to be much more than a narrow Polish problem. The pope on his part realizes clearly what a serious challenge he presents for the Kremlin. As early as 1979 during his visit to Poland he told an audience: "I'm sure there are people out there who are already having a hard time taking this Slavic pope." Hard enough, it seems, to prompt an exasperated Kremlin to cry out, as Henry II once did regarding the Archbishop of Canterbury: "Will no one rid me of this turbulent priest?"

Only two months from now, in June, the Pope pays a return visit to his Polish homeland. Will we hear yet more dramatic calls for the "spiritual union" of Eastern and Western Europe?
